TARGET AUDIENCE

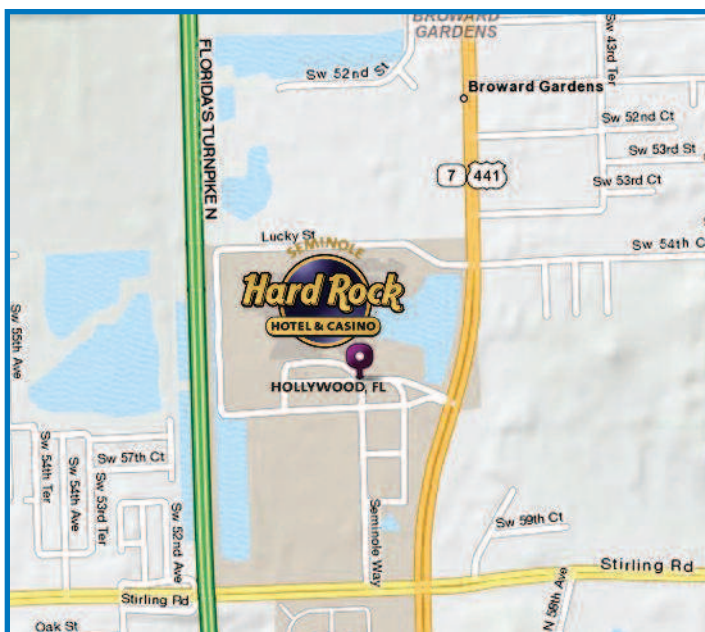
