ENTRY DEADLINE: Postal entries must be postmarked latest by Wednesday, May 18th, 2016. Late entries will be accepted with a \$10.00 late fee subject to space availability.

CHECK-IN: Must check in 30 min prior to the start of your event.

RATINGS: <u>USATT ratings as of May 22nd,</u> 2016 will be used for the purpose of conducting all draws. For players who do not have a USATT rating, an estimated USATT rating will be given based on a recommendation by a coach who knows the player or by visual evaluation of the player by a coach whenever possible.

ELIGIBILITY: All players must be USATT members. Please bring your USATT membership card or receipt. Non-members must join USATT at the tournament.

POLICIES: All ITTF/USATT regulations apply. Reference to the USATT Dress Code. All decisions of the referee are final. Players not registered within 10 min after starting time of the event may be defaulted from that event and without refund of entry fee. If a rating event is canceled or has reached its limit, player(s) will automatically be placed in the next higher event. Tournament committee reserves the right to modify prize money and/or cancel any event if there are insufficient entries. No prize money shall be awarded for splits, dumps, default losses, unfinished matches, or no-shows.

REFUNDS: After the entry deadline, no refunds. Also, refunds will not be given for any withdrawals after the deadline except when the player's rating is too high for a desired event and he or she chooses not to be promoted to the next highest event.
