On the above date and time, units responded to the above location in regards to a despondent female who was threatening to do harm to herself.

Investigation revealed that this incident resulted from a child custody issue, DCF was on scene. No one else was inside the home.

The suspect went inside the house and refused to come out and she was making threats that she would shoot herself and any police officer, that approach her.

Swat, Hostage Negotiator and VCSO along with their robot responded, a dialog was established with the female and she eventually surrender close to 2100 hours.

Evac and the Fire Department were staged close to the scene.

No evacuation occurred, residents were asked to remain inside their homes.

A 9 mm handgun and a 22 rifle was located inside the residence, no shots were fired by anyone.

The female is identified as Rebecca Yoder W/F DOB 04/24/73
