On the above date and time, units responded to the above location in regards to a despondent female who was threatening to do harm to herself.

Investigation revealed that this incident resulted from a child custody issue, DCF was on scene. No one else was inside the home.

The suspect went inside the house and refused to come out and she was making threats that she would shoot herself and any police officer, that approach her.

Swat, Hostage Negotiator and VCSO along with their robot responded, a dialog was established with the female and she eventually surrender close to 2100 hours.

Evac and the Fire Department were staged close to the scene.

No evacuation occurred, residents were asked to remain inside their homes.

A 9 mm handgun and a 22 rifle was located inside the residence, no shots were fired by anyone.

The female is identified as Rebecca Yoder W/F DOB 04/24/73

NARRATIVE The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 07 day of May, 2014, at approximately 0527 a.m. p.m. at 2202 S Peninsula Dr DAYTONA BEACH within Volusia County, violated the law and did then and there:

1 commit the offense of concealing a minor contrary to state agency or court order by concealing her child's location from the Department of Children
2 and Families.

4 On May 7, 2014 at 1727 hours, I was dispatched to 2202 S Peninsula Dr in reference to a suicide attempt. Upon arrival, I made contact with _____
5 _____, D-1's husband, and the daughter, _____ (5 YOA). Mr. Yoder stated that he and his wife had been at Dependency Court earlier in the
6 day due to prior involvement with law enforcement and DCF (Ref DBPD Report #- 140006632). In addition, DBPD officers had been in contact with
7 DCF at 4:45 (#P141271646) Per the court order, D-1 is only authorized to see her daughter two hours a day. Mr. Yoder stated that D-1 was upset
8 that he was "planning to take _____ from her," and that D-1 was inside the residence screaming, throwing things, and breaking joint property.
9 _____ advised that after leaving the courthouse, D-1 threatened to kill herself by cutting her neck with a knife or having the police shoot her.
10 _____ said that D-1 also took a handful of pills (roughly 5-10), either adderall or clonazepam. While on scene, D-1 could be heard breaking various
11 items in the house. D-1 came to the front door and yelled at officers to, "Fucking shoot her already." D-1 repeatedly yelled obscenities to officers
12 through the front door, garage door, and various windows in the house. D-1 also broke out a front window on the residence. _____ advised that
13 there was a .22 long rifle in the master bedroom closet and a Ruger 9mm handgun in the garage. D-1 armed herself with the rifle, which was later
14 discovered inside the front door. D-1 threatened to pour gasoline throughout the residence and, "burn the fucker down." D-1 then appeared in the
15 garage wearing a fireman's helmet. D-1 told Ofc. Mi. Robinson, with hostage negotiation, that the first person to come through the front door was



16 going to get shot. D-1 finally reappeared in the garage and exited far enough to be apprehended by DBPD SWAT officers. D-1 continued to be both
 17 physically and verbally aggressive, screaming at officers and flailing her arms and legs in an attempt to avoid detainment. After securing the scene,
 18 contact was made with the DCF case worker assigned to the family, Beebe, who initially called 911. Beebe stated that the family left court at 2:15 PM
 19 on the afternoon of May 7 and D-1 yelled, "Fuck you, this is not over and you will never see us again." Beebe contacted Mr. Yoder at 3:45 pm in
 20 reference to him and the daughter coming to DCF office for fingerprinting. At that time, D-1 screamed to Mr. Yoder, "You are not going to the DCF
 21 Office and you are not going to see your whore." Beebe heard D-1 yell, "Don't tell her where we are. You are never going to see us again. I am taking
 22 my daughter." Beebe stated that D-1 was irate with her due to the court order and screamed, "Fuck this! I'll shoot the house up." Beebe informed D-1
 23 at that time that she was going to call the cops. D-1 replied, "Go ahead and call the fucking cops, I'll get my rifle and shoot them too." Beebe stated
 24 that she heard the daughter during the phone call ask, "Mommy, can we go home?" To which, D-1 replied, "We are never going home because the
 25 bad people want to take you away." [REDACTED] and Ms. Beebe completed witness statements which were turned over to Records. The daughter,
 26 [REDACTED], was taken into custody by DCF and put in temporary foster care.
