TEMPORARY MEMBRANE STRUCTURE, TENT, AND CANOPY PERMIT APPLICATION

An area exceeding 120 square feet requires a permit from the Building Department. A Certificate of Flame Resistance is required with **all applications**.

Any tent exceeding 1,200 square feet and all tents located in the inner fire limits, require a Tent Permit from the Nassau County Fire Marshal and a Building Permit from the City of Glen Cove Building Department.

All tents with less than 12 feet clearance between tents will be considered as a single tent.

Tent permit fee of \$100.00 is due and permit is not to exceed one hundred eighty (180) days. All waivers of any fees and charges shall only be made by the Director of the Building Department or his/her designee in writing. Such written exception or waiver shall be made available prior to the processing of any permits, licenses, or permission of activity required by this code whereby such fee or charge would apply.

In order to obtain a permit, the following information must be provided:
