Client/ Clinical Functionality

All Programs

Create Bills for Physician Visits Report –

Hospice – New opportunity to have carrier Codes associated to zip codes to support agencies that have multiple CPT reimbursement rates.

Palliative – Agencies that have Palliative Care Programs and use the Medical Clinical Note for selecting the CPT code and documenting care will now have the ability to select the location where the service was provided. This location will flow to Additional Services when the Create Bills for Physician Visits Report is generated to write to the database.

- The agency will need to obtain a new Palliative Care Medical Clinical Note. Because the Palliative Care Program is not hard coded to one Palliative Care program ID, the Medical Clinical Note in Suncoast Solutions, which is available for import, may not appear in your Palliative Care Program if your care program ID code is different. We recommend that agencies contact training@sncoast.com for further instructions on obtaining the form and proper setup assistance.

Zip Codes – An updated zip code load will be available for import along with the 2014 CPT codes. Look for the e-mail update that will be sent to clients when these 2014 files are available for import.

Location Export to CRM– When a location is exported to CRM, the CRM start date is now the start date of the primary address for the location, allowing time sheet entries from the start date on.

Physician Maintenance – The Face to Face Encounter has been updated and a default physician is no longer displayed; the physician who provided the data must be selected. A checkbox in Physician Maintenance has been created to allow Face to Face Encounters if the Physician or ARNP has Face to Face Encounter privileges.

.Solutions Client Search – Improved Client Search to associate family members with the patient record.

Time Sheet/ Productivity (Time Clock) Report – Updated the Time Sheet report name to read “Time Sheet/Productivity (Time Clock).” When choosing the Time Sheet report from the menu, it will default to the staff name of staff currently logged in. The user can override this with themes.

Note: The report is also searchable by its new name.

Home Health Care

Home Health Therapy Threshold – Updated Home Health Therapy Threshold browser to add the option to show Order variance and improved the pay source filter on the Home Health Therapy Threshold report.

MobileLite

Manual Replication with WCF – New functionality allows mobile users to subscribe to a patient and replicate data to the server manually, without having to wait for the new store-forward replication to kick, send, and receive data at its automated times.

Note: This feature can be enabled by Support members according to the wishes of the client.

New Enterprise FTP Replication Option – Modified the MobileMaint agent to be able to use the new Enterprise FTP, as opposed to the old FTP. An option has been added to Replication Setup to allow the user to elect to use the new Enterprise FTP. The option is defaulted to “Off” (meaning that by default, service packs download using the old FTP).

Interfaces

CellTrak – Enhanced handshake functionality, adding the option to upgrade CellTrak and enhancing transmission protocol to improve data transfer. Scheduled visits now flow correctly from one aide to another if schedules are modified. Turning on this option must be coordinated through Solutions support and CellTrak.

Interoperability – Improved appearance and functionality of desktop shortcut button for Interoperability.

IPv6 – Enhanced Solutions to be compatible with Internet Protocol version 6 (IPv6). In order to make use of this feature, please contact Solutions support for assistance.
