6.3 Daycare Report

- -Dynamix will be in on the October 5th ped. day. The children will visit Free Spirit Riding School on October 12 (details in Principal's report) and scheduled on Oct 19th is Bazoo: Build a Pillow Party.
- -Registration numbers are aprox 120 daycare students and over 300 lunch students. Wendy Caron will bring final numbers to the next meeting.
- -Staffing issues are not completely resolved. Some bumping may occur, but it will be less severe then last year.
- -All daycare staff have completed a first aid course and will be receiving their certification.
- -Daycare User Committee. First meeting will be in November. Committee will meet once a month or less frequently depending on the need and level of interest. Last year most parents chose to resolve issues directly with Wendy on an individual basis. The meeting attendance numbers were quite small.

6.4 Sector Parent Report

First meeting will be in October. There is an issue with the restructuring of the sectors. The board has chosen to restructure the administrative sectors. The Central Parents Committee will have to decide if they want to remain with the current geographic structure or follow the "new" administrative sectors. Peter Rakobowchuk will advise us of new developments at our next meeting.
