If your vehicle has a **HIGH AMOUNT OF MILEAGE**, you may apply for a **REDUCTION IN YOUR PERSONAL PROPERTY ASSESSMENT**. This application must be filed annually to ensure proper reduction. Please use one form per vehicle. If you need additional applications, you may copy this form.

The high mileage discount does not apply to motorcycles, motor homes, large trucks or trailers.

REQUIREMENTS:

1. Complete and sign the application
2. Attach copies of proof. (oil change receipts, state inspection slip, repair bills) Please do not send the originals.
3. Return the application and proof to the address listed above by **MARCH 1**.

MINIMUM HIGH MILEAGE REQUIREMENTS FOR 2014

2014 vehicle required 10,001 miles or more on January 1
2013 vehicle required 20,001 miles or more on January 1
2012 vehicle required 35,001 miles or more on January 1
2011 vehicle required 45,001 miles or more on January 1
2010 vehicle required 60,001 miles or more on January 1
2009 vehicle required 70,001 miles or more on January 1
2008 vehicle required 85,001 miles or more on January 1
2007 vehicle required 95,001 miles or more on January 1
2006 vehicle required 110,001 miles or more on January 1
2005 vehicle required 120,001 miles or more on January 1
2004 vehicle required 130,001 miles or more on January 1
2003 vehicle required 140,001 miles or more on January 1

2002 vehicle required 150,001 miles or more on January 1
2001 vehicle required 155,001 miles or more on January 1
2000-1996 vehicle required 165,001 miles or more on January 1
1995 vehicles and older do not qualify for high mileage

You must file high mileage forms each year with the Commissioner's office by **March 1** in order to receive a reduction for high mileage for the tax year. It is necessary to file each year because the high mileage reduction works on a sliding scale according to the NADA book, so when your mileage changes from year to year the reduction may also change.

Please make sure to write down the mileage as of **January 1** of this year. You must also **attach proof** of mileage. The following is an example of acceptable proof:

1. The pink or white inspection slip you receive when your vehicle is inspected
2. Service or repair receipts, which show mileage and date
3. Mileage log entries you use for tax purposes
4. Title which shows high mileage

RETAIL APPRAISALS

If you believe the NADA loan value is an excessive value for your vehicle because of certain conditions such as a wrecked vehicle etc., then you can have your vehicle appraised by a reputable dealership.
