

How many coupons can I buy?

Clients can purchase a designated amount of coupons per month—a minimum of \$50 will be available for purchase monthly.

How long are coupons good for?

Coupons expire on **June 30th of the program year.**

What taxi companies do I call?

Participating taxi cab companies are listed on the inside cover of the coupon books.

How do I pay the taxi company?

Show the taxi driver your ID card and then simply pay at the end of the trip with coupons. You will probably want to offer a tip, usually 15% which you pay in cash.

Are there any limitations?

Possibly. If allotted program funds are expended before the month's end, unfilled orders will have first priority that following month.

TVP GUIDELINES

What is the Taxi Voucher Program (TVP)? Taxi service at reduced prices. Discount coupons are used for taxi fares.

Who can use TVP?

Cecil County residents who are:

- age 60 and older
OR
- persons 18 or older with disabilities
OR
- low income individuals that meet the income guidelines.

**applicants must meet 1 of the above qualifiers.*

How can I get into the Taxi Voucher Program?

Simply complete the attached application form, secure your proof of income inside, fold with the address outside, print your return address; add postage, staple or tape closed to insure privacy and mail. **Do not include payment.**

When can I use TVP?

After you apply and are certified eligible, you can purchase coupons. You can use taxi cabs to go anywhere and anytime for any purpose.

Can both a husband and wife use TVP?

Yes. However, each must apply separately.

Will I have to provide proof of my annual income?

YES. You must include proof of income WITH an income certification AND a completed application.

What proof is needed to verify income?

- Copy of your Social Security Award letter, **OR**
- A photocopy of your Social Security, SSI or VA pension disability check, **OR**
- A photocopy of your most recent income tax return, **AND**
- Documentation of any other income.

What documents do individuals with disabilities need?

Obtain a Disability Verification Form from the TVP office (call 410-996-5295 option #3) and have it completed by a qualified medical specialist.

What happens after I apply?

Once eligibility is determined, you will be mailed an identification card, a coupon order form and a USERS GUIDE.
