MENU POLICIES

Menu prices and banquet package quotes are firm for 30 days unless a signed contract and deposit have been made. Food and beverage prices are subject to change without notice. No outside food or beverage will be permitted without consent of Rhythm Kitchen. Due to Liquor Laws, no outside beverages may be brought in. All food and beverage charges are subject to 18% gratuity and NV sales tax. Event menus must be finalized at least 7 days before event to avoid rush delivery charges. If menu is not finalized charges will be determined based on menu items and will be assessed on the final bill.

PAYMENT AND GUARANTEE OF GUESTS

Changes can occur during the planning of the event until 7 days prior to event. On or before 7 days prior to the event a guaranteed number of guests is required. If no guest number guarantee is provided the last supplied estimate of guests will be used. This will be the minimum number of guests required for payment. If more guests arrive than in the estimate the difference will be assessed on the final bill due at the end of the event. All charges incurred will be settled at the conclusion of your event with the credit card on file unless other payment method has been arranged.

ROOM RENTAL TIME CHARGES

For the banquet room, there are two setup options as detailed in the banquet room packages portion. The basic banquet room package is \$150.00 and the formal banquet room package is \$350.00 (Please see banquet room packages for full package details). These charges cover use of the room for four hours. If the event runs longer than the 4 hours a room charge of \$150.00 per hour will be assessed to the final bill. If event is going to last longer than normal operating hours, arrangements must be made prior to event. Rhythm Kitchen has the right to charge additional fees for extending business hours.
