Review Letters of Intent (LOI)

The Committee and staff that reviewed LOIs discussed them for the remaining time, narrowing the 73 LOIs received to 22 for which full proposals would be invited. Decisions were based on the "Yes-Maybe-No" scores and rankings completed by each reviewer, as well as discussion during this meeting.

In the course of the discussion, several reviewers spoke in favor or against certain proposals, focused primarily on the following areas:

- Target population and health disparities addressed
- Services provided and project plans
- Feasibility of the project, both generally and for the amount of funding requested

Through the discussion, the following steps were taken to narrow the list from 73 to 22:

- All LOIs that received zero "yes" votes were dropped from consideration.
- All LOIs that received only one "yes" vote were moved to a "possible" list.
- All LOIs with five or more "yes" and several with four "yes" votes were moved through to the "invite to apply" list.
- The remaining LOIs with four "yes" votes and all LOIs with two or three "yes" votes were moved to the "possible" list.
- At this point, there were 14 LOIs on the "invite to apply" list, 40 on the "possible" list, and 19 that had been dropped from consideration.
- The Committee focused all remaining discussion the LOIs on the "possible" list and narrowed them down from 40 to eight.
- The eight remaining on the "possible" list were moved to the "invite to apply" list.

The 22 LOIs on the "invited to apply" list after discussion were:
