AFTER CAMP SIGN-OUT POLICIES:

- Camper must inform their counselor or Unit Head that they are leaving
- Camper must sign out each day at the sign-out table
- Camper is **NOT** authorized to sign-out a younger sibling from camp
- **Member** campers must have their badge at all times; **Non-member** campers may only utilize Main Street and the Café
- Camper will abide by all posted JCC policies and rules
- Camper will abide by their code of conduct and represent themselves as a responsible camper while at the JCC
- Camper can seek out a post-care counselor between 3:30-5:45pm with any questions or concerns they may have
