From Cincinnati - Start on I-71 North toward Columbus, keep left and merge onto OH-315 North toward Dayton. Take I-270 East toward Cleveland then merge onto US-23 North/ North High Street via exit 23 toward Delaware. At the first traffic light, turn RIGHT onto E Campus View Blvd. Turn RIGHT at the next traffic light onto High Cross Blvd. When High Cross ends you will be facing the Doubletree/Columbus Worthington.

From Cleveland - Start on I-71 South toward Columbus, merge onto I-270 West via exit 119B toward Dayton. Take exit 2a3 towards Delaware onto US-23 North/North High Street. At the first traffic light, turn RIGHT onto E Campus View Blvd., then turn RIGHT at the next traffic light onto High Cross Blvd. When High Cross ends you will be facing the Doubletree/Columbus Worthington.

From the West - Start on I-70 East toward Columbus, merge onto I-270 North via exit 93B toward Cleveland. Continue onto US-23 North/North High Street via exit 23 toward Delaware. At the first traffic light, turn RIGHT onto E Campus View Blvd., then turn RIGHT at the next light onto High Cross Blvd. When High Cross ends you will be facing the Doubletree/Columbus Worthington.

From the East - Take I-79 South to I-70 West toward Wheeling, merge onto I-470 West via left exit 5A toward Columbus until you reach I-70 West via the left exit. Once you enter Columbus city Limits you will need to take I-270 North towards Cleveland. Continue on I-270 North around to the north side of Columbus and exit onto US-23 North, exit 23 towards Delaware. At the first traffic light, turn RIGHT onto E Campus View Blvd, then turn RIGHT at the next light onto High Cross Blvd. When High Cross ends you will be facing the Doubletree/Columbus Worthington.

From Toledo - Take I-75 South to US Rte 15 East, which will become US Rte 23 South. Continue on US Rte 23 South to Columbus. Shortly after entering the Columbus City Limits, you will pass through the intersection of Us Rte 23 South and Flint Rd. You need to get in the far LEFT lane as you will be turning LEFT onto E Campus View Blvd at the next traffic light (the Hotel is located in the Crosswoods Center, just North of the I-270 outer belt). Turn RIGHT at the next light onto High Cross Blvd. When High Cross ends you will be facing the Doubletree/Columbus Worthington.
