Go 1.9 miles to Y in road (CR2560 & CR2675) and turn right onto CR2675. The Pirtle property is about 1/2 mile on the left. Turn into the gate at the Private Bird Hunting Area sign which is the Pirtle Property next to the LBJ National Grasslands.

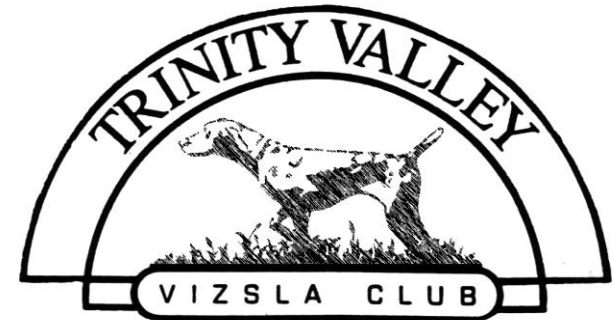
