NAZARETH ACADEMY POLICY FOR DELINQUENT TUITION/LOAN DEFAULTS

The tuition at Nazareth Academy is payable in advance of each school year in cash or through an arrangement with the local bank for loans to parents. The bank is protected from loss on these loans with the requirement that the school payoff any tuition loan should it become forty-five (45) days delinquent. As the school is placed under serious budgetary pressures in paying the bank for delinquent loans, the following policy has been formulated:

It is understood that unavoidable circumstances may arise for parents that cause delinquent payments to exist. Nazareth Academy wishes to be as accommodating as possible to any parents who suffer financial hardships and sincerely want to pay the tuition and continue their child's Catholic education at Nazareth Academy. Any parent finding himself/herself in this situation should notify the Business Manager at Nazareth Academy, and notify the bank as well.

Should the tuition loan payment approach forty-five (45) days late, the parents will be contacted by phone and/or letter requesting an immediate conference with the Business Manager and/or Principal. At all times, the parents should remain in contact with the Business office and/or Principal to resolve the problem. Should the tuition loan be charged back to Nazareth Academy, arrangements acceptable to the school must be made in writing for repayment of the monies owed. If the agreed upon plan for Promise of Payment is broken, the school, depending on the circumstances, may dismiss the child from Nazareth Academy. No child will be accepted for Re-Enrollment for the new school year if there is tuition or penalties still owed unless satisfactory arrangements are made in advance with the Business Office and/or Principal.
