

Information for Contributors to Transactions of the JSASS

The manuscript must be prepared in accordance with *the template for the technical review* or *the template for publication image*. Both templates can be downloaded from the JSASS manuscript submittal website (<http://www.jsass.or.jp/webe/>). The pdf file formatted manuscript is uploaded from this website. Refer to “*the manuscript pdf file specifications*” below.

After the author is notified for acceptance, the author is asked to submit the original manuscript files written in such as Microsoft Word , TeX source file, etc.

When the manuscript is prepared based on the template for the technical review

1. The manuscript must be written in English and double spaced. Footnotes, references, and figure captions also should be double spaced. All manuscripts must be as brief and concise as proper presentation of the ideas will allow.
2. Full Article should be made up of a cover, an abstract, main text, references, appendix and captions of figures/tables together with tables and figures.
3. *Full Articles*: A typical full article will be 8 Transactions pages in length. In terms of published A4-sized 8 Transaction pages (approximately 300 words or 2000 characters per page), the corresponding length for the manuscripts is 28-32 pages (including equations), where each normal sized figure counts as one page. Greater length usually will be unacceptable and may require reduction by the author prior to review. An excess-page charge will be imposed for each page over the first 8 Transactions pages.
4. *Cover of the manuscript*: Use the cover sheet provided in *the template for the technical review*. The title should be brief and concise (maximum of 20 words), without the use of acronyms or abbreviations. The author's name, company affiliation and other specified information must be appear in the cover sheet. If the contribution is the one which has already been presented at the JSASS conference, specify name of conference and date. Specify three to five key words preferably including at least one keyword selected from the “JSASS Standard Key Words” list in the manuscript submittal website.
5. *Abstract*: Each full article must be accompanied by a 100- to 200-word abstract, written as a single paragraph. It should be a summary and complete in itself. The abstract should indicate the subjects dealt with in the paper and should state the objectives of the investigation. Newly observed facts and conclusions of the experiment or argument discussed in the paper must be stated in summary form.
6. *Nomenclature*: A nomenclature section is required for papers containing more than a few symbols; nomenclature definitions then should not appear in the text.
7. *Introduction*: The paper also must include an Introduction -- a brief assessment of prior work by others and an explanation of how the paper contributes to the field.
8. *Mathematics*: Mathematical symbols should be italicized. To save space, the solidus (/) must be used for fractions in the text and for simple fractions in equations.
9. *References*: References must be limited to easily accessible documents. They are to be grouped at the end of

Each reference must be cited in numerical order in the text.

10. *Illustrations*: Line drawings must be clear and sharp. Computer-generated illustrations are acceptable as long as lines and graph points are dark and distinct. Lettering should be large enough to be legible after reduction. The art of hatching can be used for figures but no shading is allowed. Symbols used for these materials should be italicized in accordance with the symbols in the text. Each figure must have a caption; captions should be listed on a separate sheet. Print your name and the figure number in the margin of each figure. Cite each figure in numerical order in the text.

11. *Symbols and Units*: Use standard symbols whenever possible. The use of metric system of units (SI) is mandatory, except for unavoidable cases.

12. If figures, tables, statistics, etc. are quotations from writings of others, the source of information should be noted in the captions. It is the author's responsibility to secure such approvals as this may be required for the quotations.

13. Attach black & white illustrations or pictures in the manuscript if the author wishes to publish them in black and white. If color illustrations or pictures are attached, they are printed in color and the author must pay the full incremental cost of color publication.

14. Electronic reference file format acceptable is as follows: PDF, DOC, XLS, PPT, JPG, JPEG, PNG, BMP, ZIP, LZH.

15. *Research Notes*: Short papers may qualify for publication in this category. Research notes, not to exceed 2 Transactions pages, are intended for prompt disclosures of new, significant data or developments of limited scope; they do not have abstracts but do contain introductions and descriptions of results.

When the manuscript is prepared based on the template for the publication image

1. The manuscript can be prepared in accordance with *the template for publication image*. All manuscripts must be as brief and concise as proper presentation of the ideas will allow.

2. Greater length usually will be unacceptable and may require reduction by the author prior to review. An excess-page charge will be imposed for each page over the first 8 pages for the Full Article and over the first 2 pages for the Research Note.

3. Use standard symbols whenever possible. The use of metric system of units (SI) is mandatory, except for unavoidable cases.

4. If figures, tables, statistics, etc. are quotations from writings of others, the source of information should be noted in the captions. It is the author's responsibility to secure such approvals as this may be required for the quotations.

5. Attach black & white illustrations or pictures in the manuscript if the author wishes to publish them in black

and white. If color illustrations or pictures are attached in the submitted manuscripts, they are printed in color and the author must pay the full incremental cost of color publication.

6. Electronic reference file format acceptable is as follows: PDF, DOC, XLS, PPT, JPG, JPEG, PNG, BMP, ZIP, LZH.

Manuscript pdf file specifications applied for two types of template

- Using Adobe Acrobat is recommended when converting into pdf file.
- Version 1.5 (Acrobat 6.0) pdf file is recommended.
- Set the resolution to 600dpi or higher.
- The size of a pdf file must be less than 5MB per each paper.
- Embed all fonts (symbols, space etc.) in the pdf file.
- Do NOT create bookmarks.
- Do NOT set security.
