# PETITION TO WITHDRAW APPLICATION FOR CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY

Shell Gas (LPG) Bulk, L.L.C. ("Shell") withdraws its request for a certificate of public convenience and necessity under 1929 PA 69 ("Act 69") relative to Boyne Valley Township, saying:

- 1. On August 24, 2004, Shell filed an Act 69 application seeking a certificate of public convenience and necessity to provide propane gas service to a new development located in Boyne Valley Township, Charleviox County, Michigan. The development is identified as the Pine Valley Site Condominiums ("Pine Valley").
- 2. Pine Valley's developer approached Shell and requested service because the construction quote given to it by Michigan Consolidated Gas Company ("MichCon") was not economical or feasible for the project.
- 3. Because the developer requested service from Shell, and Shell currently does not possess a certificate of public convenience and necessity for Boyne Township, Shell submitted its application in August 2004 to the Commission requesting the same.
- 4. In November 2004, the developer informed Shell that MichCon substantially reduced its construction quote and the developer was going to go with MichCon for gas service.

- 5. MichCon has confirmed to Shell that the Pine Valley developer accepted its quote and it has or will be installing main to the development.
- 6. Although Shell would liked to have received an Act 69 certificate to serve the Pine Valley development, there is no longer a customer to serve.
  - 7. Shell is hereby withdrawing its application in this case.

WHEREFORE, Shell respectfully requests that this Honorable Commission:

- A. Issue an order allowing Shell to withdraw its application in this docket; and
- B. Grant such further relief as it deems appropriate.
