# NOTICE OF EXPANDED CALLING AREAS AND PROPOSED RATE ALTERATION

Many of you have contacted us to request an expanded local calling area. As a result, we are currently seeking approval from the Michigan Public Service Commission ("MPSC") to expand our local calling areas. In MPSC Docket No. U-14195, we, Pigeon Telephone Company, are proposing to offer expanded local calling from the Alba exchange to the Bellaire, Gaylord, East Jordan, Mancelona, and Elmira exchanges, in addition to the Lakes of the North exchange; from the Lakes of the North exchange to the Gaylord, Grayling, Mancelona, and Manistee River exchanges, in addition to the Alba exchange; from the Pigeon exchange to the Bay Port, Owendale, Sebawaing, Caseville, Elkton, Bad Axe, Gagetown, Unionville, Cass City, Kinde, and Port Austin exchanges; and from the Twining exchange to the East Tawas, Prescott, Whittemore, Omer, and Au Gres exchanges.

In addition to asking the MPSC to approve our expanded local calling plan, we are also proposing to change the rates for residential, business, and educational basic local exchange service. If our application with the MPSC is approved, in the Alba, Lakes of the North, and Pigeon exchanges we will change the monthly residential basic local exchange rate to \$22.55, our monthly business basic local exchange rate to \$27.11, our monthly private branch exchange (PBX) rate to \$36.40, and our educational and multi-line business one-party and PBX rates to \$24.61 and \$33.90. If our application with the MPSC is approved, in the Twining exchange we will change the monthly residential basic local exchange rate to \$21.07, our monthly business basic local exchange rate to \$23.37, our monthly private branch exchange (PBX) rate to \$26.30, and our educational and multiline business one-party and PBX rates to \$20.87 and \$23.80. The estimated amount of the rate change for the typical residential, one-party line customer is \$6.00 monthly (or \$72.00 annually), and \$7.20 monthly (or \$86.40 annually) for the typical business customer. If approved, Pigeon's application will also result in blocking 1+ originating toll calling from each of our four exchanges to the expanded local calling areas (eliminating the need to dial '1' before calls to the other identified exchanges), and each of Pigeon's customers would receive a monthly 2,000 minute calling allowance for calls placed to the expanded local calling areas, with additional minutes in excess of the monthly allowance charged at \$0.04 per minute. Local calls occurring entirely within the customer's home exchange and local calls between the Alba and Lakes of the North exchanges would not count against the 2,000 minute allowance.
