



'CLASS CLASSIC REWARDS' TERMS AND CONDITIONS

By entering the "Class Classic Rewards" competition (LTPS/13/00548), you are agreeing to the following terms and conditions:

1. STANDARD TERMS

- 1.1 Information on how to enter forms part of the terms of entry.

2. WHO CAN ENTER?

- 2.1 Entry is open to all registered businesses in **Australia (hereafter 'eligible entrant')** who administer a minimum of twenty five (25) Self Managed Super Funds (SMSF).

3. HOW TO ENTER

- 3.1 The competition commences on **Wednesday 13th February at 08.00** and concludes on **Friday 15th February 2013 at 11.00am**.
