Thank you for coming to FanFest at Safeco Field today! Please carefully review the following information and, if you still wish to participate in the Zip Line attraction after reading this information, please sign this form to indicate your agreement.

Activity Information and Waiver of Liability

I, the undersigned, desire to participate in the Zip Line attraction at Safeco Field today (the "Zip Line"). I agree that my participation in the Zip Line is entirely voluntary. I also understand that I will be subject to the rules and regulations of Safeco Field, and that for my safety and the safety of others, I may not enter areas or perform activities without express permission from a representative of (collectively, the "Seattle Mariners").

I understand that the Zip Line requires me to climb up stairs and wear a harness to slide down the cable, and that I must fit into the harness and weigh between 45 and 250 pounds to participate in the Zip Line. I agree not to participate in the Zip Line if I do not meet the weight requirements or if I have any health conditions affecting my ability to participate. I acknowledge that participation in the Zip Line may involve inherent risks, dangers and hazards, which may occur without warning, or be due to lack of conditioning, carelessness of myself or others, and other unforeseen or unexpected perils inherent in such activities. I understand the risk and danger of accidents, physical injury, or death associated with my participation in the Zip Line, and I accept all such risks.

I understand that the Seattle Mariners and Clowns Unlimited, Inc. ("CUI") are not responsible for me, including any injury or damage to me or my property, while I am participating in the Zip Line. **I promise not to sue or bring a claim** against the Seattle Mariners or CUI or their directors, officers agents or employees for any claims, injuries, or damages that may occur as a result of my participation in the Zip Line. I hereby **release, hold harmless and indemnify** each of the above parties from any and all liability or loss of any kind or nature, known or unknown, resulting from my participation in the Zip Line, including, without limitation, liability or loss arising from the negligence, omission or failure of any of them to exercise reasonable care or diligence.

Permission to Use Likeness

I understand that during or in relation to my participation in the Zip Line, the Seattle Mariners may photograph, record and/or film me or otherwise capture my voice, likeness or image and, in return for the opportunity to participate in the Zip Line, I agree that the Seattle Mariners may each use such photographs, tapes, film or other recordings for any promotional, fund raising and commercial activities they wish, without further compensation to me.
