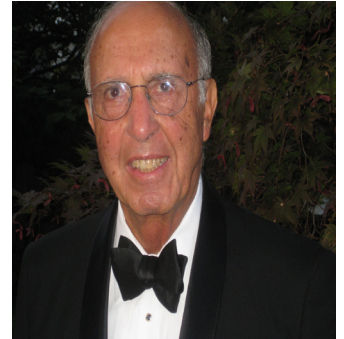

Hours after Pearl Harbor on December 7, 1941, the Secret Service found themselves in a bind. President Franklin D. Roosevelt was to give his infamy speech to Congress the next day and, although the trip from the White House to Capitol Hill was short, agents weren't sure how to transport him safely.

At the time, Federal Law prohibited buying any cars that cost more than \$750, so they would have to get clearance from Congress to do that, and nobody had time for that

One of the Secret Service members, however, remembered that the US Treasury had seized the bulletproof car that mobster Al Capone owned when he was sent to jail in 1931. They cleaned it, made sure it was running fine and had it ready for the President the day after.

And run properly it did. Capone's car was a sight to behold. It had been painted black and green so as to look identical to Chicago's police cars at the time. It also had a specially installed siren and flashing lights hidden behind the grille, along with a police scanner radio. To top it off, the gangster's 1928 Cadillac 341A Town Sedan had 3,000 pounds of armor and inch-thick bulletproof windows. Mechanics are said to have cleaned and checked each feature of the Caddy well into the night of December 7th, to make sure that it would run properly the next day for the Commander in Chief. The car was sold at an auction price of \$341,000 in 2012.

**SMC: October 22, 2013**  
**Speaker's Remarks**

---

Roger Myers, president and CEO of Presbyterian Villages of Michigan (PVM), was our guest speaker. Having served in that role for over twenty years, he had a long history of experiences to draw upon with ties to this area and our organization. In fact, Mr. Myers has been a speaker for us previously. He noted that several of the PVM Board members are also members of our organization. Accompanying our speaker were Lynn Alexander, vice president of Public Affairs, and David Miller, vice president and director at the Village of East Harbor in Chesterfield Township.

PVM was founded in 1945 in Redford and has since grown to 26 locations across Michigan... as far north as Harbor Springs and to the west in Jackson, Battle Creek and Kalamazoo. Alpena, Mt. Pleasant, Westland, Holly, Pontiac and Port Huron are also part of the PVM portfolio. Most significant in terms of proximity for Grosse Pointe are there six locations in Detroit and their Village of East Harbor, which is a full CCRC (Continuing-Care Retirement Community).

A major thrust of the presentation was about the changing landscape of aging services and that of PVM. They have refocused their efforts with innovations. The new Rivertown location in the heart of the Detroit riverfront is the first of its kind in the country offering affordable options all the way from adult daycare (The Center For Senior Independence) to independent (2014) and assisted living. Over the next several years they will add two "Greenhouse" nursing homes with a capacity of ten residents each living in a style which most closely matches being at home. This initiative is in partnership with

United Methodist Retirement Communities and Henry Ford Health System. PVM also has five other Detroit locations and has been a long-time supporter of the city. They will also be adding more services to allow seniors to stay in their own homes and yet be connected to their communities. In fact, PVM in partnership with the Hannan House in Detroit, has launched "Community Connections" in Greater Midtown Detroit. It is a "community based, member driven network that connects residents and others to trusted information, valued services, and enriching relationships"

Mr. Myers also talked about the fact that PVM has a governing board for each of their locations as well as an overall corporate board and a foundation board. Many talented people have helped PVM to become the leader in senior housing and services through their board participation. In fact, more than several of their board members have also been members of ours. He invited any of us who may be interested to consider a board position

with PVM and also invited all to tour any of their locations, especially The Village of East Harbor. Also of note is that PVM is in the pre-development phase of another potential Detroit location in partnership with Hartford memorial Baptist Church. More and more we will be seeing like-minded organizations coming together to support seniors and their communities. He wanted to let folks know that you don't have to be Presbyterian to reside at a PVM location or receive Services. Their mission is to serve people of

all faiths. In conclusion, the times are changing. People are living longer, more vibrant lives and want to remain independent yet connected to others. We all need to adapt to these changing times and look to the future with promise and exploring the possibilities for a quality life. ## Investment Seminar - October 22, 2013

*Speaker: Leon LaBrecque, JD, CPA*

Leon has spoken to our noon meeting, having given an extremely interesting presentation on a trip to Korea and China with his family. This meeting he mentioned a provision in tax law that few in attendance were aware of. Due to its implementation time limit it is herewith presented verbatim as a service to the entire membership of the Senior Men's Club of Grosse Pointe.

What is QCD provision?

A provision called the qualified charitable distribution (QCD) allows individuals over 70 ½ to have all or part of their required minimum distribution (RMD) taken directly from an IRA and donated to a qualified charity. This provision is only valid through the tax year of 2013 and there are a number of considerations:

- Allows for contributions up to \$100,000.
- Unlike RMD, QCDs are not subject to ordinary federal income taxes.
- Most community foundations qualify to receive contributions under the QCD provision.
- No Donor Advised Funds.
- No 509(a)(3) supporting organizations.
- Make sure to consult the IRS or a CPA experienced in charitable giving to be certain the organization you wish to donate to qualifies

Consider an Example

Susan is 72 years old in 2013. She has \$1,100,000 in her IRA which is subject to a RMD of \$42,969. She has \$16,800 in pension income, receives \$18,500 from Social Security, and makes \$6,000 in dividends and interest. Susan takes a standard federal deduction.

Susan can maintain the status quo and simply take the RMD or she can use the QCD rule to support a qualified charity of her choice while realizing some significant tax advantages.

She takes the RMD. If Susan takes the RMD

her income is \$81,494, which includes \$15,725 of taxable Social Security. Her taxable income is \$69,994. Susan's Federal tax is \$13,427 and her Michigan tax is \$636.

She does a QCD. If Susan denotes the sum of her RMD to a qualified charity, her income is lowered to \$26,325, which includes only \$3,525 of taxable Social Security. Her taxable income is now only \$14,825, which results in Federal tax of \$1,778 and Michigan tax of \$97. Susan saves \$12,188 of tax on her \$42,969 contribution.

Bottom Line

If you are subject to RMDs and have significant levels of other income (i.e. dividends, Social Security, etc.), you should talk to a qualified advisor about using QCD for the year 2013 to significantly reduce the tax burden characteristic of a large RMD while making a charitable contribution to your local community foundation.

# The Swerve

### How the World Became Modern

by Stephen Greenblatt

The author tells us in some detail the why of the limited survival from antiquity of the writings on papyrus rolls or in parchment books. He introduces us into the life and travels of Poggio Bracciolini, a Vatican copier staff person most of the 1400's and famed book hunter, who combed the monasteries of Europe to uncover ancient works. His find was Titus Lucretius Carus' epic poem, ON THE NATURE OF THINGS from ca. 50 BC. The author identifies its recirculation as the "swerve" in his book title. Incased in the verses is the view that the universe is atoms in motion in a void with random collisions over time accounting for everything. There is no creator. There is no evidence of intelligent design. The soul dies with the body, and there is no judgment after death. Pleasure is the highest goal of existence. The poem gives life to the Greek philosopher of human life Epicurus' s teachings.

The "swerve theory" didn't get acceptance from our Readers who saw progress or science, building on past knowledge, and not liberated by a poem. Stephen Greenblatt, is a gifted writer, researcher and a humanities Professor at Harvard. What he watched for and tells is how individuals fared who took hold of the ideas in the poem and worked a life path from them. Sadly many caught in the frenzy their advocacy created suffered death by burning at the stake. Was Greenblatt in telling his stories fair or concealing a prejudice against organized religion? Readers seemed to favor the author.

Ideas from Lucretius' s poem appear in the writings of the French essayist Montaigne, and in writing in Spain and even in England's Thomas More's UTOPIA. In More's case his insistence that Utopians accept the view of an after life is seen as distracting from his saintly characterization coming from his conflict with Henry VIII.

The book ends quoting Thomas Jefferson at age seventy-eight. "I am an Epicurean." At a much earlier age in the Declaration of Independence, Jefferson wrote: "All men are endowed by their creator..."

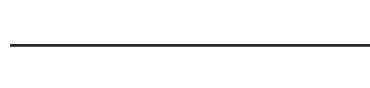
