

Consequences:

Infractions that disrupt the learning environment and are beyond the normal scope of classroom management. These infractions can also involve injury or threat of injury to other students. The codes in the chart can be read with the following key: **ISS = In School Suspension and OSS = Out of School Suspension**. Any student issued out of school suspension will be required to meet with both their parents and a member of the administrative team before returning to class after the suspension. Students will not be allowed to participate in school-related functions (clubs, sports, performances, etc.) when serving an Out of School Suspension.

To School Tardies (Unexcused)

Elementary, Middle, and High School:

You are considered tardy if you are not in homeroom by 8:00 a.m. You are allowed 3 tardies per nine weeks without consequence. After 3 tardies each subsequent tardy will result in lunch detention.

To Class Tardies

Middle and High School Tardies:

You are considered tardy if you are not in your assigned classroom at the end of the allotted class change time. Teachers will assign lunch detention after 3 tardies and for each subsequent tardy. This will start over each nine weeks.
