

All applicants shall:

- 1. Produce a valid insurance policy document or a policy cover note satisfying the requirements of Part 6 of the Road Traffic Act 1988 and confirming that the insurance is suitable for private hire use. **The original document must be produced**.
- 2. Produce a valid MOT certificate, completed within the last month.
- 3. Produce the attached Vehicle Mechanical Test certificate duly completed by an MOT registered garage.
- 4. Produce a Vehicle Registration Certificate (V5 Form).
- 5. Send the completed application form, along with the above documents, to the Environmental Enforcement Manager and Licensing Officer, Broadland District Council, Thorpe Lodge, Yarmouth Road, Thorpe St Andrew, Norwich, NR7 0DU.
- No fee is payable for a transfer application which relates to a change of ownership or change of owner's address. If the transfer application relates to a change of vehicle, a fee of £_____ is payable. Please note that the Council Offices can no longer accept cash payments.

Note: On initial application the vehicle must not exceed five years of age and shall be no less than 1300cc.
