RULES AND REGULATIONS

1. Open to any woman Amateur who is a member of an affiliated club or an amateur golfer affiliated to a governing body recognised by WGSА. Handicap limits are set out on the official entry form. Current handicaps on the 1st day of play shall apply.
2. The Championship shall be played in accordance with the Rules of Golf as approved by the R&A Rules Limited and approved local rules.
3. The Tournament Committee shall consist of the EPWG Executive.
4. Any disputes connected with the tournament shall be decided by the Tournament Committee. Disputes connected with the championship must be lodged with the Tournament Committee within 15 minutes of completion of the round. This information may be requested in writing.
5. All entries shall be subject to the approval of the Executive Committee and no entries will be accepted from players whose handicaps have lapsed. The Tournament Committee reserves the right to limit the field by eliminating in handicap order followed by date of receipt of entry.
 - a. **Stroke Play Championships:** **FORMAT:** All Divisions play stroke play
Ties: A sudden death play-off over designated holes will determine the winner. (See Notice Board)
 - b. **Match Play qualifying places:** The WGSА count-out method will be used.
FORMAT: All Divisions play off scratch handicaps.
6. The draw will be conducted by EPWG and will be placed on the website www.epwg.co.za. The general numeric draw will be applied for the Match Play events.
7. Competitors must report to the starter 10 minutes before their advertised time of play. Any competitor who is absent from the tee when called upon to start will be disqualified or penalised under Rule 6.3. Disciplinary action may be taken against any non-arrivals.
8. Pace of play will be enforced.
9. In the event of inclement weather the Tournament Committee shall have the right to alter the conditions of play in all events.
10. Players must conform to the dress regulations stipulated by the WGSА and the rules of the club. Soft spikes only.
11. Players in the A Division may not ride in motorized golf cars. Players in the B and C Divisions are allowed to ride in a motorized golf car. Registered caddies together with **Guest caddies** will be allowed. A **daily** registration fee of **R20.00** will be charged. They will be issued with an official armband."
12. The use of legally authorised GPS distance measuring devices are permitted, refer to rule 14.3.
14. Unauthorised use of cell phones on the course is a breach of etiquette. Offenders will be warned and may be subjected to penalties under Rule 33.7
15. Handicaps as on 1st day of the tournament – verification may be requested
16. Spectators must keep off tees, fairways and greens at all times and are not to interfere with any player. The use of golf cars by spectators is NOT permitted.

EXEMPTION OF LIABILITY CLAUSE

The Union and its management will not be held responsible for any damages, loss, including personal loss and or other forms of loss, harm or injury sustained by any person for the duration of the Tournament.

The Union will not be held liable for any of the following:

- i) Physical and/or emotional injuries suffered during the Tournament/Championship, due to any acts of God, suffered as a direct result thereof, including aspects such as being struck by lightning, etc.
- ii) Physical injuries of any kind suffered by a person, including a player or spectator sustained by own negligence, or otherwise.
- iii) Emotional injuries sustained due to any loss, including death, suffered as a result of any of the above injuries sustained personally or by spectator.
- iv) Damages suffered to any property of a player.
The player acknowledges the exemption of liability of the Union and its management as listed above when she signs the acknowledgement and also acknowledges the contents of the above, understands it, and exempts the Union from any liability as indicated above.

The Union does not warrant or guarantee the safety of any person.
