

Participant Agreement, Liability Release and Acknowledgement of Risk

1. I have read and understand the description of the tournament and the Official Rules of this tournament. I will obey all rules and understand that any violation may result in immediate disqualification without refund of my entry fee. I also understand that tournament officials may reject my application for any reason and in that event will refund my entry fee.
2. I understand and acknowledge that competitive fishing is a dangerous sport, the risk of which includes, though not exclusively, drowning, collision in the water, and injuries from hook and other fishing paraphernalia. I voluntarily assume the responsibility for these risks, identified and not identified, and all risk of injury or death or damage to myself or my property or to others, including spectators and their property, arising from my participation in the tournament.
3. I hereby release, discharge, and agree to hold harmless and indemnify The Catch-A-Dream Foundation, The Brayden Lynn Bass Classic, their respective officers, sponsors and tournament officials and all other persons or entities associated with the tournament from any and all liability, claims, demands, actions or right of actions which are related to, arise out of, or are in any way connected with my participation in this tournament, including specifically but not limited to the negligent act or omissions of The Catch-A-Dream Foundation, The Brayden Lynn Bass Classic, their respective officers, tournament officials and all other persons or entities associated with the tournament, for any and all injury, death, illness or disease, and other damages or loss to property suffered by myself or others. In signing this document, I acknowledge and agree that if anyone is hurt or property is damaged while I am engaged in this event, I will have no right to make a claim or file a lawsuit against, The Catch-A-Dream Foundation, The Brayden Lynn Bass Classic, their respective officers, tournament officials and all other persons or entities associated with the tournament, even if they or any of them negligently caused the bodily injury or property damage.

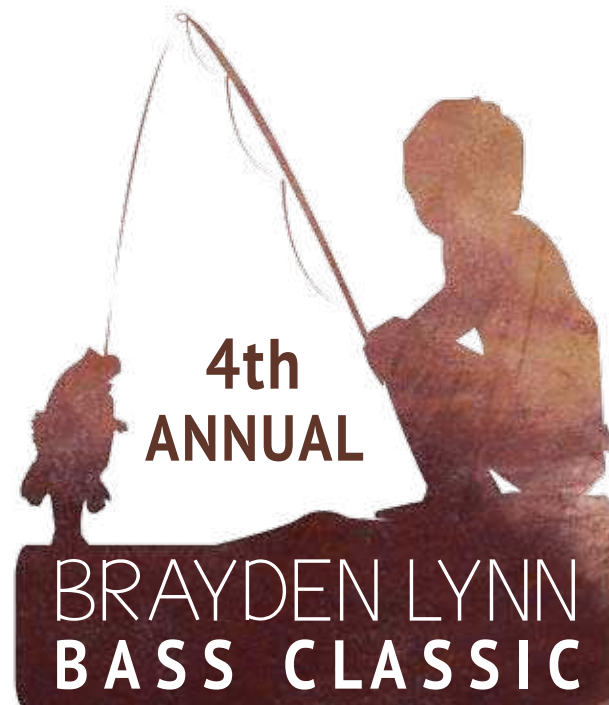
In Loving Memory **Brayden Lynn** 8/21/02 – 7/9/11

2. PARTICIPANTS AND ELIGIBILITY: All contestants must have a valid Louisiana fishing license. Any contestant under the age of 16 years of age must be accompanied by a parent or designated adult guardian. Proof of age to the satisfaction of tournament officials is responsibility of prospective competitor.

3. REGISTRATION: A properly completed and signed official application form and the \$100 registration fee must be submitted to tournament officials. Team blast off positions will be in order of entry received. Refund of entrance fee will be made only under emergency circumstances.

4. BLAST-OFF AND WEIGH-IN: Blast-off will be at safe light. Weigh-in will be at 3:00 pm. Tournament awards will be presented immediately following the weigh-in.
