North Atlantic Cod - \$20.00 8-0z. Ribeye - \$20.00 Broasted Chicken - \$18.00


All dinners are served with baked potato, salad, and fresh baked bread. VAA Chapter 37 will provide all nonalcoholic beverages at no charge.
