<u>Local Police Report</u> - P.C.S.O. Natalie Bingham attended the meeting to discuss the three reported incidents during May 2012. Cllr. Mrs. E. Robinson asked for some K-9 leaflets. Cllr. Mr. T. Green joined the meeting at this point, 7.30pm.

Report by Chairman of the Finance Working Group - Cllr. Mr. T. Green presented the finance report showing the forecast to the end of the financial year. The Jubilee events raised a total of £510 for the blue plaque scheme. An explanation of variances was given. Cllr. Green was thanked for his hard work with the accounts.

<u>End of Year Accounts</u> - The accounts for the year ended March 2012 were presented to the Council by the Responsible Finance Officer, and subsequently approved and signed.

Completion of Internal Audit - The Clerk circulated a letter from the Internal Auditor, Mr. G. Lawson, received on completion of the internal audit of the Council's books for the year ended March 2012. It was advised that all appropriate records had been well maintained, budget control was strong and the Council worked within the controls set.

Annual Audit Return for Year Ended March 2012 - It was advised that the Annual Return Statement of Accounts had been prepared for audit. After circulation/discussion, the document was subsequently approved and signed by the Chairman and Responsible Finance Officer.

<u>Annual Governance Statement</u> - The Clerk circulated the Annual Governance Statement which was subsequently approved by the Council and signed by the Chairman and Clerk.

<u>Localism Act 2011 Code of Conduct</u> - The Clerk had provided each Member with a copy of the East Riding of Yorkshire Council Member Code of Conduct prior to the meeting, to enable a full discussion to take place at the meeting. The Chairman highlighted areas of concern for discussion/agreement. Cllr. Mr. M. Whitehead advised Members that the new Standards Board Committee does not include any Parish Council representatives and therefore if a Member was reported to the Standards Board, the matter would be dealt with by East Riding Councillors.

The Clerk was asked to seek approval from the Head of Legal Democratic Services at E.R.Y.C. to make the following change and addition to the Code of Conduct; Item (6) (1) (b) be replaced with 'Retire from the meeting room' and also insert a note at the bottom of page 5 'If a Member of this Parish Council is referred to the Standards Board Committee, we would like a Parish Councillor present on that Committee'.

1708 Highways

Cllr. Mrs. E. Robinson advised that a compliant had been received via email from a resident about the West Ella Road verge. It was reported that E.R.Y.C. had been and sawn up the ivy but left it under the hedge bottom. Cllr. Robinson was asked to forward the email onto the Clerk to enable this matter to be taken up with Highways, E.R.Y.C. Cllr. Mrs. E. Robinson and Cllr. Mr. M. Whitehead advised they would be happy to meet with an Officer to explain exactly what work is required.

Cllr. Mr. T. Green advised that the footpath near the first bus stop opposite the Kirk Ella/West Ella boundary between the village signs also needs attention, water and mud continually collects there due to the dip in the footpath.

Cllr. Mr. D. Jordan advised that the sight line near the village sign on Rilpingham Road is highly dangerous due to overgrown tree branches, the Clerk was asked to report this to E.R.Y.C. and request it is dealt with as a matter of urgency.

Cllr. Mr. M. Whitehead advised that the planting of the daffodil bulbs last year had been a huge success. The Clerk was asked to order ten sacks again for planting this year.

Cllr. Mr. M. Whitehead gave an update on the upgrade of the A164 and advised that residents should email him if they have any questions/concerns about the works.
