BYLAW No. 1752, 2014**

2014 TAX RATE BYLAW

A Bylaw for the Levying of Rates for Municipal, Regional Hospital, Regional Library, and Regional District Purposes for the Year 2014

The Council of the City of Armstrong in open meeting assembled enacts as follows:

1. The following tax rates are hereby imposed and levied for the year 2014:
 - (a) For General Municipal purposes of the municipality on the value of land and improvements taxable for general purposes, rates appearing in column "1" of Schedule "A" attached to and forming a part of this Bylaw.
 - (b) For Regional Hospital purposes on the value of land and improvements taxable for hospital purposes, rates appearing in column "2" of Schedule "A" attached to and forming a part of this Bylaw.
 - (c) For Regional Library purposes on the value of land and improvements taxable for general purposes, rates appearing in column "3" of Schedule "A" attached to and forming a part of this Bylaw.
 - (d) For Regional District purposes on the value of land and improvements taxable for hospital purposes, rates appearing in column "4" of Schedule "A" attached to and forming a part of this Bylaw.
 - (e) For Regional District Insect Sterilization purposes on the value of land taxable for hospital purposes, rates appearing in column "5" of Schedule "A" attached to and forming a part of this Bylaw.
 - (f) For Regional District Fire Dispatch purposes on the value of improvements taxable for hospital purposes, rates appearing in column "6" of Schedule "A" attached to and forming a part of this Bylaw.
2. This bylaw may be cited as "City of Armstrong Annual Tax Rate Bylaw No. 1752, 2014".
