

Bowood Platinum Membership

MEMBERSHIP FEES

Platinum Single membership (26 years+)

£1698 per year

Allows 7 day access to the golf course, 7 day access to The Spa facilities and access to House and Gardens during the open season. This can be taken by one individual or can be split between a couple - one nominated member of the golf course and one of The Spa. Also includes 5 golf guest passes and 5 spa guest passes.

Platinum Joint membership (26 years+)

£2875 per year

Allows 7 day access to the golf course, 7 day access to The Spa facilities and access to House and Gardens during the open season for two adults.

Platinum 5 Day Single membership (26 years+)

£1240 per year

Allows 5 day access to the golf course, 5 day access to The Spa facilities and access to House and Gardens during the open season. This can be taken by one individual or can be split between a couple - one nominated member of the golf course and one of The Spa.

Platinum 5 Day Joint membership (26 years+)

£1660 per year

Allows 5 day access to the golf course, 5 day access to The Spa facilities and access to House and Gardens during the open season for two adults.

Platinum Youth membership (19 years - 25 years)

£860 per year

Allows 7 day access to the golf course, 7 day access to The Spa facilities, access to House and Gardens during the open season for a youth between the ages of 19 and 25.

Platinum Junior membership (up to 18 years)

£358 per year

Allows 7 day access to the golf course, 7 day access to The Spa facilities, access to House and Gardens during the open season for a junior up to the age of 18.

Platinum Family membership

£3549 per year

Allows 7 day access to the golf course, 7 day access to The Spa facilities, access to House and Gardens during the open season for two adults and two juniors up to the age of 18.

Payment required in advance for the year by annual direct debit, cash, debit or credit card (please note that there will be a £25 administration charge per person for payment by credit card). Prices are inclusive of VAT at the current rate.

TERMS AND CONDITIONS OF PLATINUM MEMBERSHIP

Applying for Platinum membership implies acceptance of these terms and conditions.

General

- 1) Payment is to be made by annual direct debit, cash, debit or credit card as an annual, in advance. Please note that payment by credit card will incur a £25 administration charge per person.
- 2) Platinum membership is an annual contractual agreement and therefore no part refunds of the annual payment shall be given.
- 3) If a direct debit fails the club reserves the right to request immediate payment by cheque, cash or credit card for all outstanding fees and to levy the £25 credit card payment fee in addition. In such cases the direct debit facility will be withdrawn for future years.
- 4) The membership year runs from 1st April - 31st March. Annual membership is automatically renewed on 1st April each year. Members wishing to resign at the end of the membership year must inform the membership secretary in writing by letter or email no later than 20th March.
- 5) Each person applying to become a Platinum member shall complete the standard application form.
- 6) In the event of a couple joining the Platinum Single membership, both members must reside at the same home address and direct debit payments must be collected from the same bank account.
- 7) Memberships are non-transferable.
- 8) The Proprietor of Bowood Hotel, Spa and Golf Resort is the Marquis of Lansdowne.
- 9) Management: comprises of the Proprietor and General Manager, who meets as and when necessary to decide the affairs of the golf course and Spa. may add to, repeal and amend the terms and conditions as may be necessary for the efficient and harmonious running of the resort; shall have the sole authority for the interpretation of all Golf and Spa rules; reserves the right to suspend or expel any person if they abuse the rules or display inappropriate behaviour.
- 10) Platinum membership includes free entry to Bowood House, Grounds and Rhododendron Walks during the season on presentation of membership card (member only). Excludes special events.
- 11) Bowood does not accept liability for the loss, theft or damage of a members' personal items.
- 12) Bowood, its agents or servants shall not be held responsible for any claims for loss or damage to property or for any injuries sustained by those visiting the premises.
- 13) Membership does not infer the right to use Bowood Hotel, Spa & Golf Resort for non-golf or non-spa activities such as walking, jogging or cycling, except as permitted on acknowledged public footpaths.

Golf

- 14) All golf members have reserved tee-times until 10.30 am at weekends.
- 15) All golf membership categories may use the Academy Course free of charge. There are no tee times reserved for the Academy Course.
- 16) All golf membership categories except Academy and Junior Academy may obtain and maintain a handicap.
- 17) All golf membership categories except Academy and Junior Academy, may participate in the Club competitions including Medals, Stablefords, Winter and Summer Knockouts.
- 18) An annual golf diary will be published and issued to all adult golf members, containing telephone contact details provided by the members (unless specifically opposed).
- 19) Guest rates are subject to change.
- 20) Affiliation fees are payable annually as follows: Gentlemen and Junior Boys to the English Golf Union & Wiltshire County Golf Union, Ladies and Junior Girls to the English Ladies' Golf Association and Wiltshire Ladies' County Golf Union (Ladies are also required to pay fees to the Ladies' Golf Union)
- 21) Prospective members may be required to have an interview.
- 22) Members elect two committee representatives to administer handicaps and competitions under the C.O.N.G.U. and E.L.G.A. rules.

- 23) Members are confined to amateur status as defined by The Royal and Ancient Club of St.Andrews and will be affiliated to the L.G.U and the W.C.G.U.
 - 24) Tee times must be booked in advance.
 - 25) At times the course may be fully booked for specific events.
 - 26) Membership cards must be carried when visiting the club. This card remains the property of Bowood Golf and Country Club.
 - 27) You must report the loss of your card to the Club. There is a charge of £5 to replace a lost, stolen or damaged card.
 - 28) All players MUST register in the Pro Shop prior to playing. Guests, Country & Academy Members MUST pay prior to play.
 - 29) The course and clubhouse shall be open at such hours as the club may from time to time determine. The Club may close the course or clubhouse to meet the prevailing circumstances but will always try to give sufficient notice of its intentions. In the case of bad weather conditions a last minute decision may be unavoidable.
 - 30) All facilities are open to members of the public.
 - 31) Only appropriate smart casual dress is accepted on the course; this includes collared shirts, tailored slacks and knee length shorts (with long socks or sports socks). Denims and non-tailored shorts and training shoes are not permitted. Hats are not to be worn in the internal bar and dining areas of the clubhouse.
 - 32) Anyone wishing to file a complaint about any aspect of the running of the Club must do so in writing to the General Manager.
 - 33) No person is permitted to bring food or drink onto the premises.
 - 34) Visitors are requested to stay within the boundaries of the course.
 - 35) Dogs are not permitted on the course, or in the clubhouse.
 - 36) Players who reserve tee-times and then fail to play or cancel their tee-time may be suspended in accordance with suspension procedure displayed on the noticeboard.
 - 37) In the event of wet weather, trolleys/buggies may be banned to protect the course, when a trolley/buggy ban is in force no exceptions will be made.
 - 38) To ensure all players have a chance to play at busy times, a 4-ball pair up policy may be adopted.
 - 39) The use of mobile telephones in the bars, dining area and on the course is strictly forbidden.
 - 40) The board may add to, repeal and amend the rules and bye-laws, as may be necessary for the efficient and harmonious running of the Club.
 - 41) The board shall have the sole authority for the interpretation of all Club rules and bye-laws.
 - 42) The board reserves the right to suspend or expel any person if they abuse the bye-laws and rules or display inappropriate behaviour.
- ## Spa
- 43) Prospective members must complete the health screening questionnaire and have their photo taken for The Spa entry system.
 - 44) The Spa shall be open at such hours as the management determines.
 - 45) All members must present their Spa Membership card and register at The Spa reception prior to using the facilities.
 - 46) The member's card remains the property of Bowood Hotel, Spa & Golf Resort. Members must report the loss of a membership card to The Spa. There is a charge of £5 to replace a lost, stolen or damaged card.
 - 47) Management may close The Spa to meet prevailing circumstances but will always try to give sufficient notice of its intentions.
 - 48) Anyone wishing to file a complaint about any aspect of running The Spa must do so in writing to the General Manager.
 - 49) No person is permitted to bring food or drink into the premises.
 - 50) Dogs are not permitted in The Spa or associated environs.

- 51) The use of mobile telephones within in The Spa is strictly prohibited.
- 52) Members receive 4 complimentary guest passes per membership year.
- 53) Children under the age of 14 must be accompanied by a responsible adult at all times when in The Spa.
- 54) The following minimum ages apply in The Spa: Gym - 16 years, Rock Sauna and Crystal Steam Rooms - 16 years.
- 55) Children's access times to the pool are as follows: 8.30am - 10.00am, 3.45pm - 5.00pm, 7 days a week. We respectfully request that all children vacate The Spa within 15 minutes of the children's access times coming to an end to allow a return to tranquility for our spa users.
- 56) Specific instructions for use of all leisure facilities are posted on The Spa notice board. These must be strictly adhered to and Bowood accepts no liability for members' failure to observe these instructions and accordingly use of these facilities will be solely at the risk of members.
- 57) The Spa must be vacated when requested by management or on the sound of the fire alarms.
- 58) All persons who use The Spa do so on the express basis that the use is at their own risk.
- 59) It is recommended that members seek medical advice before undertaking any exercise in The Spa if a medical condition is known of.
- 60) Bowood accepts no liability for any illness, injury, over-exertion, precipitation or aggravation of a medical condition caused by use of The Spa by members, guests or hotel residents.
- 61) Bowood reserves the right to approach any member who appears to be causing a disturbance to other users of The Spa, or appears to be under the influence of alcohol or drugs, and requires such person to leave The Spa area.
- 62) Nothing in these terms and conditions of The Spa shall limit or exclude Bowood's liability to members or guests for death or personal injury caused by Bowood's proven negligence.
- 63) Bowood may terminate the membership, without liability to the member at anytime, for any reason.

Food & Beverage Levy

- 64) Members subscribing to the Levy Scheme will benefit from a 15% discount applicable to food and beverage purchases within the Clubhouse Brasserie, Shelburne Restaurant, Shelburne Bar and Spa Bar. Levy holders also receive discount on purchases from the Halfway House. Other discounts will be available throughout the season as published/advertised.
- 65) The Levy is available to all members. To subscribe, an initial payment of £120 inclusive of VAT, is due on 1st April. Those wishing to subscribe must do so, via the Membership Secretary by emailing membership@bowood.org. If joining the levy during the season a sum equivalent to £10 per month for the remaining months of the year is payable.
- 66) Monies will be held on each individual account to spend throughout the year. 'Top ups' in £20 denominations can be made at any food and beverage point of sale terminal, at any time during the year.
- 67) To obtain the 15% discount, all purchases must be accompanied by the membership swipe card. The till receipt will automatically show the balance of the member's account after each sales transaction.
- 68) The card may only be used by the member, whose signature appears on the reverse side.
- 69) On 31st March, funds remaining in credit on the account cannot be carried forward to the following season, unless the original £120 has been spent and 'top ups' have been made. Carrying forward a credit does not remove the need to pay a further £120 at the start of the new membership year.
- 70) No refund of levy payments or top ups will be made on cessation of membership.
- 71) Those not subscribing to the Levy Scheme will be charged at the full-published rates for all purchases.
