Introduction

On August 3, 2015 President Obama and the Environmental Protection Agency (EPA) announced the Clean Power Plan (CPP) to reduce power plant carbon emissions 32% by 2030 (from 2005 levels). The administration billed it as “an historic step in reducing carbon pollution from power plants that takes real action on climate change.” For the first time the United States—the world’s largest emitter of the greenhouse gases that contribute to climate change—committed to reduce carbon pollution from power plants, the source of more than 31% of our greenhouse gas emissions (GHGs).

The new policy is a fundamental part of the U.S. strategy to address climate change. At the same time, it will also have important health, economic, and environmental implications for frontline communities disproportionately affected by pollution and climate disruption. These are the Indigenous, African American, Latino, Asian, Pacific Islander, and poor white communities leading the Climate Justice Alliance.

And the Climate Justice Alliance (CJA) has something to say to the state and regional leaders now preparing to implement the Clean Power Plan.

The CJA “Our Power Plan” provides an environmental justice counterpoint to the Clean Power Plan. It was produced by 19 member organizations within the Climate Justice Alliance who plan to engage with the EPA throughout the implementation process. The “Our Power Plan” points out critical oversights in the EPA’s Clean Power Plan and proposes improvements to the Federal and State Implementation Plans that:

- develop alternative incentive mechanisms that allow EJ communities and households to directly participate and access efficiency incentives **outside a carbon trading process**;
- reduce and **regulate carbon emissions and pollutions equitably across the supply chain**—from the point of energy extraction to power plants that are overwhelmingly located in indigenous and minority communities;
- eliminate regulatory loopholes and incentives for **all dirty energy**, including natural gas, incineration, biomass, nuclear power, and coal;
- increase emphasis on and resources for **energy efficiency**;
- further **prioritize frontline and low-income communities** to ensure they directly benefit from investments and employment in renewable energy and conservation.

Call to Action

CJA members will converge on the 10 EPA regional office headquarters Jan. 19, 2016, to mark the end of the final public comment period for the Federal Implementation Plan model of the CPP. These peaceful protests and press conferences will launch the “Our Power Plan,” the Climate Justice Alliance’s answer to the Clean Power Plan. What you can do...

 - Send someone to scope out the area for a likely site & research municipal, state, or federal property security rules for public rallies in that location
 - Plan out the event in any way that works for your group. For example:
 - Enact formal presentation of Our Power Plan to EPA
 - Issue a statewide / regional call to action (to whom, for what)
 - Rally / artful action (chant, dance, paint, sing, ...)
- Create **social media buzz**:
 - Create a Facebook Event page for your Action so folks can sign up
 - Tweet Our Power Plan messages at EPA offices and media outlets
 - Post (or create your own) graphic memes on Facebook and Twitter
 - Livestream from your action using Periscope.tv (send link to CJA!)

About CJA's Our Power Campaign	
A series of statements explaining <i>who</i> CJA is and <i>what</i> the Our Power Campaign leaders believe. To repeat in any written messages about CJA/OPC and use to build spoken remarks in interviews, press conferences, rallies, etc.	
Climate crisis is a symptom of a dangerous economic condition	The climate crisis is a symptom of a deeper problem: an economy based on extraction and exploitation of resources and people. This economy benefits a few at the expense of communities and the planet. The urgency of our climate crisis demands that we directly confront political and economic structures that support a dig-burn-dump economy and foster deep inequality.
Extractive energy is more than fossil fuels	Extractive energy includes nuclear, coal, oil and gas, waste incinerators, biomass energy and other forms of energy and fuels that pose extreme risk to human and ecosystem health, community resilience, economic certainty, and climate stability.
Who is on the frontlines of the climate crisis, pollution, and economic crisis	In frontline communities are the families disproportionately harmed by energy extraction, pollution, and climate disruption. Coal-fired power plants in the U.S., for example are responsible for at least 1,530 excess deaths and tens of billions of dollars in health and environmental damages every year. Who lives within 3 miles of a coal-fired power plant? <ul style="list-style-type: none"> ● Households with an average income 15% less than average ● And 39% are people of color—8% more than the U.S. average.
The most vulnerable also the most innovative	On the frontlines of the climate crisis are low income people, communities of color, and indigenous communities. We are the hardest hit by both <i>climate disruption</i> —the storms, floods and droughts—and the extractive, polluting and wasteful <i>industries causing global warming</i> . At the same time, the ingenuity, resourcefulness and resiliency within frontline communities can offer innovative community-led solutions to ensure a just transition off fossil fuels, and that support an economy good for both people and the planet.

<p>Just Transition is about a better economy and society, with climate benefits</p> <p>It Takes Roots to Weather the Storm.</p>	<p>CJA’s vision of environmental justice is transformative rather than corrective.</p> <p>Communities across the country are united for a Just Transition that keeps extractive energy in the ground, creates millions of meaningful jobs, and puts our communities back to work building the infrastructure we really need to address the climate crisis.</p> <p>This means clean community energy, and also zero waste; regional food systems; public transportation; efficient, affordable, and durable housing; and ecosystem restoration and stewardship.</p> <p>A Just Transition must protect communities and workers that are the most vulnerable to pollution, climate disasters and economic disruptions. And it must create meaningful work and dignified, good-paying jobs. For this reason, frontline communities and workers must be in the forefront of shaping the new economy.</p>

EPA/government officials	The "Our Power Plan" represents the innovation and experience of frontline communities living with the daily reality of climate and economic disruption. Through the frontline community organizing of the Climate Justice Alliance's <i>Our Power Campaign</i> , the Our Power Plan will be used to (1) protect the integrity of the Clean Power Plan and (2) make sure the Implementation Plans adhere to principles of environmental justice.
Press/Bloggers	While the political wrangling around the Clean Power Plan continues, frontline communities living with the daily reality of climate and economic disruption have quietly created an Our Power Plan.
Allies (workers, big green, etc)	In the spirit of "nothing about us without us," Our Power Plan is the <i>real</i> Clean Power Plan. It captures the vision of environmental justice from frontline communities living with the daily reality of climate and economic disruption.
In the Our Power Plan: concerns about the CPP	The Clean Power Plan is a good start but key elements stand in the way of a just transition. Carbon trading provisions allow polluters to pollute at the source, with already vulnerable and over-burdened communities (particularly communities of color and poverty) disproportionately affected. And it creates loopholes that allow for dirty energy alternatives like nuclear power, biomass, carbon sequestration, waste incineration and increased use of natural gas.
In the Our Power Plan: proposals for the CPP implementation process	The Our Power Plan provides a strong injection of equity to the CPP. Improve the community engagement process. Eliminate loopholes for dirty energy alternatives. Conduct environmental justice analysis for each source. Prioritize energy efficiency and clean/renewable energy over dirty energy alternatives. Eliminate market solutions/carbon trading.
