Tom has been one of the leading influences and activists in the branch

since he joined in 2006. He is outspoken, enthusiastic and very positive about the benefits of becoming a Sir member. Although not currently a Branch Officer, Tom is viewed as a branch leader by our membership. A spokesman at the monthly luncheons, Tom also is a tireless "behind the scenes" worker that every branch needs to be successful.

Shortly after becoming a member, Tom was appointed Facilities Manager where he surveyed other potential luncheon locations. When he recommended the Dante Club, he was selected to facilitate that change.

Our branch has always published a bio of any new members in the monthly newsletter. When the editor was overwhelmed with this difficult position, Tom volunteered to be the branch biographer. With the influx of new members, this is an important and time consuming endeavor. An excellent bowler, Tom also became the Secretary of the Bowling League and its spokesman in 2011. Under his leadership, the bowling league has expanded from 8 to 12 teams.

Tom spent 3 years as a Director greatly assisting the Big Sir. In preparation to his becoming a Little Sir, then a Big Sir. Tom served as Asst. Secretary. Tom did a great job when he was appointed as the branches Little and Big Sir. He is especially adept at another task he performs as the branches recruitment chairman. As a recruiter, Tom got us back on the right track to improve our membership. He writes a column in each monthly newsletter on recruiting and talks about it at every luncheon. He formulated the idea of improving recruitment by making arrangements for a booth at the Haggin Oaks Golf Exposition for the last three years. No easy task. It took hours of negotiations, communications and preparation but this approach has recruited a nucleus of 15 young members on our current 2015 roster who have also brought in their friends. This has snowballed making a significant impact to our membership that has increased from 106 to 144 in three short years. This success has not been lost on other branches whom at least two secured booths at the golf exposition.

Tom has also been known to visit our sick or ailing members to talk to them and see how they are doing.

Tom's efforts as an officer for the branch, and especially his continued contributions before and after serving as an officer, show why he deserves this award.

The bowlers, both team members and substitutes, pile up prize money based on their wins and for high handicap and scratch scores. Last year, the league handed out over \$5400 in prize money. Even more important, we had fun!

Speaking of fun, Tod Davis and Alex Canada recently travelled to Paradise (near Chico) for a SIR bowling tournament there. Later in July, several of us are going to Pollock Pines for another SIR tournament. I'll keep you posted on the results.
