GENERAL

- 1) EFFECTIVE PRICE DATES. All prices quoted in this contract remain in effect only until 30 days after delivery of previews are released and are subject to additional charges or increases in prices thereafter.
- 2) All measurements referred to in this agreement are in inches.
- 3) DEPOSIT: A deposit of \$250.00 or equal to the photography fee will be provided by Client when this contract is signed. The deposit is not refundable on cancellation by the Client. A further deposit of 50% of the original agreement will be paid prior to the wedding. Upon delivery of the previews on CD/DVD the balance of the original agreement including the taxes will be paid. Preview or orders must be placed or returned within 30 days.
- 4) On selection and return of the previews one-half of the order is due. The remainder of the balance is due and payable when the order is ready for delivery to the client.
- 5) Each wedding is considered "one" contract, regardless of number of individuals receiving photographs. The Client only will be billed for the entire order. No prints or albums will be released until the total contract price has been paid in full by the Client who assumes exclusive payment responsibility.
- 6) Additional service charges at \$65.00 per hour will be payable for service beyond the terms of this contract including overtime caused by delays not within the control of the Studio/Photographer.
- 7) The Client agrees not to reproduce, or to permit reproduction, in whole or in part, by any means whatsoever, of the digital images, positives, or photos delivered for preview or purchased Until a printable CD/DVD is purchased.
- 8) The Studio/Photographer shall have the right to use any and all photographs taken hereunder for display or exhibit purposes and to publish such photographs for publicity and advertising purposes unless otherwise agreed in writing.
- 9) The Studio/Photographer is the exclusive contractor for the services described herein. To ensure the best quality photographs, and to avoid interruption or distraction, only the Photographer/Studio will be permitted to take photographs at any location, except the church and reception.
- 10) The Studio/Photographer is not liable for damages, including but not limited to, delay or omissions, arising from inherent equipment defects or fault, or other causes beyond its control. Liability in any event is limited to refund of deposit only.
- 11) This contract constitutes the whole on the agreement between the Client and the Studio/Photographer. Verbal understandings are not binding unless added hereto by way of attended notes for double signature.
- 12) Signature: Our signatures here below confirm that we/I have read and understand the terms of this Wedding Photography Agreement and that the information provided is accurate and that we/I agree to be bound by its terms and conditions.
