AGREEMENT:

_____(initial) Owner hereby agrees that he/she will not bring, or permit to be brought, any dog under his/her control, to any class or upon the premise where such class is being held while such dog has or has been exposed to, to the owner's knowledge, distemper, parvovirus, or any other communicable disease or parasites.

_____(initial) Owner further agrees that he will not bring to any class, a dog that is known to be vicious or otherwise dog and/or people aggressive.

_____(initial) Owner also agrees and understands that Kamp Kanine may refuse to admit any dog to any of its classes or premises, and may, with cause, dismiss any dog from class or from the premises.

_____(initial) Owner Understands and Agrees to the Following;

- No Injured or Sick Dogs will be allowed on the premises.
- All dogs must enter and exit on-leash.
- Each dog must have an adult handler.
- Owner must pick-up after their dog(s).
- No un-altered dogs over 6 months of age.
- ALL dogs must be current on vaccinations.
- Only well-socialized and friendly dogs ae allowed on the premises.
- Children must have direct adult supervision.

RELEASE OF LIABILITY:

By signing this agreement, you as the Owner of the dog(s) participating in this class and throughout it's duration, acknowledge and agree that you understand the potential dangers involved with the activities conducted on these premises and that your attendance or participation can result in injury and harm to you, your dog and any guest(s) you bring with you. You the owner of your dog(s) agree to release and hold harmless and release from any and all liability Kamp Kanine, its agents, volunteers, employees, associates and all affiliates including Rancho Coastal Humane Society for any accident and or any and all forms of injury sustained by you or your dog(s), or any guest(s) you bring onto this property as a result of your participation, attendance or observation in the activities, classes or events conducted on these premises. Furthermore, you acknowledge and agree that you are fully responsible for any property or personal damages or injuries caused by your dog(s) while anywhere on these premises whether inside or outside the actual agility yard.

Admittance to class will not be allowed without signed agreement, class payment and proof of required vaccinations.
