## <u>Documents required for a visit visa for Sri Lanka</u>

- 1. Duly filled and signed Visa application form.
- 2. Original passport (minimum validity of 6 months beyond the period of stay).
- 3. Two recent passport-size (45x35mm) colour photograph, one of which is to be pasted in the Visa application form.
- 4. Visa Fee must be paid when submitting an application, payable at the counter or through Postgiro. **The Embassy does not accept cheques.** If sending the documents by post, please enclose copy of payment receipt. Please check the Embassy website or call the Embassy on Tel No. 0046 8 6636523/25 for visa fee particulars.
- 5. Confirmation is required of the travel arrangements, copy of return air ticket or flight itinerary obtained from a Travel Agent.
- 6. Self-addressed envelope.
- 7. Photocopy of the Resident/Stay Permit is required. (For for non-nationals of Sweden, Denmark, Finland, Iceland, Estonia, Latvia, or Lithuania only)

Note: Applicants are adviced to submit their application at least one month before scheduled journey.
