### **Documents required for a visit visa for Sri Lanka**

1. Duly filled and signed Visa application form.
2. Original passport (minimum validity of 6 months beyond the period of stay).
3. Two recent passport-size (45x35mm) colour photograph, one of which is to be pasted in the Visa application form.
4. Visa Fee must be paid when submitting an application, payable at the counter or through Postgiro. **The Embassy does not accept cheques.** If sending the documents by post, please enclose copy of payment receipt. Please check the Embassy website or call the Embassy on Tel No. 0046 8 6636523/25 for visa fee particulars.
5. Confirmation is required of the travel arrangements, copy of return air ticket or flight itinerary obtained from a Travel Agent.
6. Self-addressed envelope.
7. Photocopy of the Resident/Stay Permit is required. (For for non-nationals of Sweden, Denmark, Finland, Iceland, Estonia, Latvia, or Lithuania only)

**Note: Applicants are advised to submit their application at least one month before scheduled journey.**
