PSOP Information

PSOP was our guest speaker at the April Membership Meeting and they shared with us so many interesting programs, some of them open to all, that we wanted to recap in the newsletter. First, the free programs offered to all include tax preparation for simple forms and the Vial of Life. The Vial of Life is kept in the refrigerator and has all of your vital information inside, including emergency contacts, existing health conditions and a list of current medications. This information is critical if there is an emergency responder in your house. Additionally, there are many programs offered for older residents in our neighborhood, including: in home senior companions, hearing impaired telephones, Lifeline (free, depending on income), Tuesday and Thursday lunches, dances, travel programs (both locally and abroad) and computer classes. There are also many different volunteer opportunities for seniors in our community. They coordinate a foster grandparent program and lead a Retired Senior Volunteer Program. Property Tax Bill

Property tax bills have gone out and you should have received yours by now. If you haven't, please contact the County Assessor's Office at (618) 825-2704. There are a few exemptions that can save you little money on your bill. They include the Homestead Credit, Senior Freeze, Disabled and Veteran. If you should be receiving these credits, be sure to check that they have been applied.

If you feel your bill is too high and you have confirmed that your exemptions have been applied, please contact the assessor's office so they may review your bill and either correct it, or help clarify the assessment value and taxing rates.

If your assessment value is incorrect, you will need to have an appraisal done and file an appeal with the St. Clair County Board of Review.

Please note that the first installment is due on July 1st, 2015. The second installment must be received by September 1st, 2015.

Neighborhood Watch

You may have noticed that old Neighborhood Watch signs have been replaced with new signs around the neighborhood. We have been fortunate enough to have this update completed. However, did you know that our Neighborhood Association got its start as a Neighborhood Watch group. Neighborhood Watches are very important to our community, but what exactly is a Neighborhood Watch? Neighborhood Watch, in its current form, dates back to the 1960's, but Americans have used this concept since Colonial times. It is a crime prevention program that relies on neighbors keeping an eye out on their communities and not only being aware of suspect activity, but reporting it to local law enforcement. They also help spread information to their neighbors on securing their property to make it less inviting to criminals. Watch groups also help with beautification projects and neighborhood Watch. Recently, Lt. Eiskant shared a few tips to keeping an effective Neighborhood Watch group in your block.



Observe and Report Low Level Crimes

Broken Windows, Downed Tree Limbs, Abandoned or Unlicensed Vehicles, Drug Houses, Hand to Hand Deliveries, Burglaries of Sheds, Cars or Homes, Intimidation, and Suspected Child Abuse

Report All Crime

The squeaky wheel gets the grease. As a matter of fact, this is the number one reason we have the neighborhood we do. We must continue to call and report suspicious activity and work with the police to keep communication open regarding problem properties.

Always Lock Your Car Doors

Not only will they pass up locked cars but they will get your personal information from the contents of the glove box and sell or use it themselves. You have given that information to them on a silver platter. Also remove personal information and valuables from a car at the attendant driven car wash, valet parking, auto repair.

Know What Times are Opportune for Crime

Most car burglaries occur at night. They will usually pass up locked vehicles. Home burglaries mainly occur between 7 a.m. and 5 p.m.
