Arena Building Block Loan Agreement

between FC Gelsenkirchen-Schalke 04 e.V., Ernst-Kuzorra-Weg 1, 45891 Gelsenkirchen, represented by the Executive Board, referred to in the following as S04, and

- 1 By signing this loan agreement, the Fan makes a binding commitment to help finance the VELTINS-Arena by pledging an Arena Building Block.
- 2 For each Building Block pledged, the Fan loans the arena the amount of 250 euros. Upon conclusion of this agreement, the Fan shall transfer the amount of 260 euros (250 plus 10 euros for the Building Block Certificate) to the account of S04 at the Genossenschaftsbank Essen, IBAN DE51 3606 0488 0300 3004 00 (BIC: GENODEM1GBE) or shall pay this amount in cash or by EC card/ credit card at the S04 Service Center.
- 3 In return, the Fan will receive the following services: From the beginning of the season following the conclusion of this agreement and after payment of the loan, the Fan will receive every year for ten years a 25-euro voucher redeemable at the S04 shop. After ten years, the 250 euros will therefore have been reimbursed by S04.
- 4 For supporting the Arena project, the Fan will receive:
 - Upon request, a "Building Block" with personal name plate in the Fan Wall in the main entrance area of the VELTINS-Arena for the duration of the loan. The placement and size of the "Building Blocks" will be determined by S04.
 - The Fan can choose the text for "his or her" Arena Building Block. A maximum of 30 characters (including spaces) is possible per Building Block. If no text is specified, the Building Block will remain blank. S04 is entitled to refuse the desired text with good reason.
