- Loans are repaid over 50 weeks.
- Once we've received your Child benefit payment your loan will be transferred to your nominated bank account.
- Loan repayments are £12 a week or £48 a month.
- You will be required to save £8.70 each week in your child benefit savings which cannot be withdrawn until the loan is paid in full. If you have more than one child, the remaining child benefit can be saved in a separate savings account. If you wish to make regular share withdrawals, you will need to apply for a prepaid debit card.
