All amounts due for labor, materials, and services furnished by **Century Plumbing Wholesale, Inc.**, including but not without limitation amounts due for sale and delivery of plumbing supplies and related construction materials and amounts due for plumbing supplies and related construction materials destroyed, lost, missing and stolen through the fault, inadvertence, misconduct or negligence of any part including the customer are due payable to **Century Plumbing Wholesale, Inc.**, at its principle place of business 901 SW 69<sup>th</sup> Ave, Miami, Florida 33144 – during regular business hours. All amounts due to **Century Plumbing Wholesale, Inc.** are payable in full on "C.O.D." cash on delivery basis unless other payment terms are agreed to in writing between the parties.

All amounts due for labor, materials and services furnished by **Century Plumbing Wholesale, Inc.**, including but not without limitation amounts due for sale and delivery of plumbing supplies and related construction materials and amounts due for plumbing supplies and related construction materials destroyed, lost, missing and stolen through the fault, inadvertence, misconduct or negligence of any party including the Customer are payable at two percent (2%) 10<sup>th</sup> net 20<sup>th</sup> (prox.) from the date of invoice. When an account becomes delinquent, **Century Plumbing Wholesale, Inc.**, reserves the right to suspend all account privileges. On or after the 25<sup>th</sup> of any month all invoices not paid by the Customer are deemed past due and become subject to a service charge of 1.5% percent per month, or the highest rate allowed by law, together with all expenses incurred in the collection of any past due amounts including a reasonable attorney's fee.

The customer shall promptly notify **Century Plumbing Wholesale, Inc.**, by certified mail of any change in the ownership of said company. ### IMPORTANT NOTICE REGARDING THE FLORIDA CONSTRUCTION LIEN LAW

**Century Plumbing Wholesale, Inc.**, qualifies as a "lienor" under chapter 713 of the Florida statutes and retains the right to enforce its claim for payment for amounts due for labor, materials and services against the real property upon which improvements are being constructed. Please be advised that the Florida Construction Lien Law authorizes **Century Plumbing Wholesale, Inc.**, to enforce its right to recover such amounts directly from the owners of real property upon which improvements are constructed. The Supplier shall not discharge the obligations incurred hereunder by death of the Guarantor.
- II. This Guaranty creates joint and several liability with all other obligations assumed by and enforceable against any other persons, corporations or entities including, but without limitation, general contractors, subcontractors, professional lienors, the owners of real property subject to the rights and responsibilities created by the Chapter 713, Florida Statutes (*the Florida Construction Lien Law*) and any and all other persons, corporations and entities answerable for



the indebtedness incurred by the CUSTOMER. The GUARANTOR expressly waives any right to require the SUPPLIER to proceed against the CUSTOMER to proceed against any general contractor, subcontractor, professional lienor, the owner of real property subject to the rights and responsibilities created by the Chapter 713, Florida Statutes (*the Florida Construction Lien Law*) and any and all other person, corporation and entity answerable for the indebtedness incurred by the CUSTOMER pursue any other remedy in its power whatsoever.
