**WITHDRAWAL/REFUND POLICY:**

**30 day written notification** to the Artistic Director **is required** if a Student is withdrawn from the program. (Notifying the instructor is not acceptable) Upon official withdrawal, tuition for the semester in which the Student has registered will be refunded according to the following schedule less an administrative fee of **\$25** and less the **\$50** Non-Refundable Registration Fee:
