What is Payroll Giving?

Payroll Giving is a scheme that allows you to give to charities such as Renewable World straight from your gross salary (before tax is deducted), and to receive immediate tax relief of up to £4.50 for every £10 donated. It is an easy, tax-effective way to give, meaning you can give more, for less!

Why give to Renewable World through payroll?

More than 1.3 billion people worldwide have no access to electricity. Without access to modern energy services people find it more difficult to lift themselves out of poverty and local businesses, communities and schools struggle to function properly. Indoor air pollution from paraffin, wood, grass or animal dung used for lighting and heating contributes to the deaths of nearly 2 million people every year – mainly women and children. Your support would help Renewable World to transform the lives of people living in poverty by providing access to modern energy services to:

- Improve livelihoods and increase income – access to energy enables communication and trade, supports the establishment of new income generating ventures and stimulates enterprise.
- Improve health - healthcare is more accessible because local clinics can keep medicines refrigerated and equipment can be powered. The effects of smoke inhalation are reduced as a result of clean home lighting sources.
- Improve education - children can study after dark, schools can access IT resources and open later for adult education.

Payroll donations provide Renewable World with a regular, reliable income stream that enables us to plan and budget for the future whilst reducing our administration costs.

How to give through your payroll – it's as easy as 1, 2, 3!

1. Fill in the form overleaf, telling your employer how much you want to give Renewable World
2. Your employer will forward your completed form onto the Payroll Giving Agency (PGA) and deduct from your pre-tax salary the total amount you want to give
3. The PGA will distribute your monthly donation to Renewable World. Your donation may take a few weeks to be received by us, but you should see your donation appearing on your payslip within the next month or two.

It's flexible too!

- You can give as much or as little as you like
- You can change the amount you give
- You can stop donating at any time

Without access to energy for pumping water, Sumina (above) and her family had to spend hours daily collecting water and tending crops. In the dry season, there was not enough food grown to feed her family or to sell. Sumina had to spend what little money she had on food and so struggled to pay for her children's education.

A hydraulic ram pump is now pumping enough water for Sumina to grow and sell a wide range of crops all-year round. Sumina can now pay for her children's education and she hopes to save money to continue to support their studies.
