NO ASCA NUMBER REQUIRED UNLESS YOU WANT TO EARN ASCA TITLES.

A jump card must be provided at registration unless previously submitted and/or unless the dog is entered in the 20"+ classes.

For Exhibition Only (FEO) entries will be accepted for dogs over 15 months.

Entries limited to 350 runs per day.

Pre-Trial entries open **March 20, 2014** and close **April 24, 2014** or when entry limits are reached. Day-of Trial entries will be accepted up to 30 minutes before classes entering if limits have not been met.
Day-Of Entries are \$15 for each run.

*Any dog younger than 18 months of age must jump at least 4" lower than their 'standard' jump height.

***The TN ASC Conformation, Rally and Obedience June Jubilee
has changed dates and location and has added Agility.***

ENTRY INFORMATION

ENTRIES

1. **Pre-Trial Entries** must be postmarked by **April 24, 2014** after which time no pre-trial entries will be accepted or cancelled. A secondary closing date of **April 27, 2014** at 1:00 pm will be for advancement in level only for dogs entered by the first closing date. Notification must be made in writing (email accepted) and you must receive a new conformation from trial secretary before move up is considered valid.
2. **Day-of entries accepted on May 2, 2014** and up till 30 minutes before class entering if limits have not been met.
3. No entries will be accepted by phone or fax. Express mail entries must include the signature waiver allowing them to be left at the secretary's address. No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.
4. Illegible entries will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a \$20 collection fee to the amount of each returned check.
5. To be accepted, entries must be made on the enclosed entry form. Copies may be made. Entries must be signed, complete, include the agreement and paid in full to be accepted. **You may enclose a copy of a permanent jump height card (ASCA, AKC or NADAC) with your entry and avoid having to be measured for this trial.**
7. **You may enter without an ASCA tracking number;** you just won't be getting your Q's recorded with ASCA. Dogs must be registered with ASCA to have their titles tracked with ASCA. You may enter as "pending", but need to send in your registration forms to ASCA at the same time. We are not responsible for lost Qs if you do not register with ASCA in a timely manner. If you have any questions about obtaining an ASCA tracking number, send an email to agility@asca.org. Forms are included in this premium, or can be downloaded from www.asca.org/Forms.
8. Day to Day Move-ups over the weekend will be accommodated, provided the information is given to the Trial Secretary before the trail ends each day.

FEES

SCHEDULE

The show site will open for general crating from 6:30pm until 7:30pm on Friday, May 2, 2014.

Check-in Saturday morning will start at 7:00 and judging begins at 8:00 a.m.

Check in Sunday morning will start at 7:00 and judging begins at 8:00 a.m.

Please be aware of start times for each day!

You are responsible for being present when it is your turn to run. We will not hold the ring for absent handlers. Conflicts with obedience, rally, and conformation will be accommodated.

All dogs that have to be measured must be completed by 8:00am Saturday. Please be on stand-by for measuring as soon as measuring time begins, approximately 7:30 am Saturday. All dogs that have to be measured on Sunday must be completed by 8:00 am. Please be on stand-by for measuring at approximately 7:30am.

OBSTACLES

The following obstacles may be used at this agility trial: Weave Poles (24" spread), Non-winged single hurdle(s), Dog walk (slatted, rubber surface), Tire Jump non-displaceable (24" inner center), Winged single hurdles, A-frame (slatted, rubber surface), Teeter-totter (rubberized, no slats), Double bar hurdle, Closed tunnel/chute solid barrel, Open tunnels

AWARDS

There will be one small gift per dog/per week-end entered in appreciation of your participation in the TNASC agility trial.

TNASC will award ribbons for 1st through 4th places in each jump height for all classes.

Dogs jumping 24" will be placed with the 20+ jump heights in all classes.

Dogs jumping 16"/16+ will run as a group. However, awards will be managed as follows: 16" Regular, 16" Vets and 16" Junior Handler. 16+ will be included in the appropriate 16" designation.

A green qualifying ribbon will be awarded for all ASCA registered dogs earning qualified scores in ASCA titling classes.

All prizes and awards must be claimed on the day awarded, no awards will be mailed.

HIGH IN TRIAL AWARDS

The Tennessee Australian Shepherd Club will offer seven High in Trial Awards each day.

Three awards will be presented in the Standard Division: **High in Trial Novice, Open, and Elite**. Dogs must be entered in the same level in all classes to be eligible for the Standard Division level awards. One award will be presented in the Veterans Division: **High in Trial Veteran**. This award will be presented to the highest scoring Veteran Aussie or non-Aussie. Dogs do not have to be entered in the same level in all classes to be eligible for this award.

One award will be presented in the Junior Handler Division: **High in Trial Junior Handler**. This award will be presented to the highest scoring Junior Handler without regard to the breed of dog entered. Dogs do not have to be entered in the same level in all classes to be eligible for this award. Two overall awards will also be presented: **High in Trial Aussie and Non-Aussie**. Dogs do not have to be entered in the same level in all classes to be eligible for this award.

High in Trial Qualifying points earned shall be dependent upon the class level in which qualifying scores are earned. Each faultless qualifying run in Regular Agility, Gamblers or Jumpers shall be given the following HITQ point value: runs in an Elite class shall be given 7 HITQ points, runs in an Open class shall be given 6 HITQ points, runs in a Novice class shall be given 5 HITQ points. Each faulted (.01 to 5 faults) qualifying run in Regular Agility shall be given the following HITQ points: Elite 3.5 HITQ points, Open 3 HITQ points and Novice 2.5 HITQ points.

REFUNDS

1. **No refunds will be made after the closing date of April 24, 2014**, or in the event that a dog is absent, disqualified, excused by the judge or the club, or barred from competition by the action of the Organizing Committee except that of a bitch that comes in season after being entered. A refund less \$4 per entry to cover expenses will only be issued if the Trial Secretary receives a Veterinarian's certificate.

2. No entry fees will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, act of God, public emergency, act of public enemy, strike or any other cause beyond the control of the organizers.

SITE INFORMATION

MAP & DRIVING DIRECTIONS TO THE TRIAL SITE

From Knoxville: Take I-40 West towards Nashville. Go about 35 miles and take the US-27 exit (Exit #347). Turn LEFT onto US-27 and go 2.3 miles. Follow "From US-27" below.

From Nashville: Take I-40 East towards Knoxville. Go about 130 miles and take the US-27 exit (Exit #347). Keep LEFT at the fork in the exit ramp. Turn LEFT onto US-27 and go 2.1 miles. Follow "From US-27" below.

From Chattanooga: Take I-75 North towards Knoxville. Go about 85 miles and take the I-40 West exit (LEFT fork). Go about 20 miles and take the US-27 exit (Exit #347). Turn LEFT onto US-27 and go 2.3 miles. Follow "From US-27" below.

From US-27: To TN-382 and Roane State Community College (RSCC). Turn LEFT onto 382 towards RSCC. Go 1.0 miles, passing RSCC on the right, and immediately turn RIGHT towards the Expo Center parking areas. The Expo Center will be on your left. Follow signs to competitor's parking areas on the north and west sides of the building. Do not block driveways on the arena level entrances! **Camper hookups** are on the east side of the building. When you turn RIGHT off TN-382, make an immediate LEFT. Follow signs for camper hookups.

NOTICE TO COMPETITORS

This event is sanctioned by the Australian Shepherd Club of America, hereinafter referred to as "ASCA".

This trial will be held under the current rules and regulations of the Australian Shepherd Club of America. For a complete listing of the rules, visit www.asca.org.

TNASC, its board of directors, ASCA, and the property owner assume no responsibility for any loss, damage, or injury sustained by the exhibitors, owners or to any of their dogs, personal property, or children.

Through submission of entry, the competitor acknowledges that they are knowledgeable of ASCA rules and regulations, including, but not limited to the following:

1. All ASCA Agility trials shall be open to purebred and mixed breed dogs.
2. All healthy, trained dogs over eighteen (18) months of age are eligible to compete in ASCA Agility Trials. Bitches in heat, lame, or blind dogs are ineligible for entry.
3. Any dog which demonstrates aggression towards any person or any dog, whether inside the ring or outside the ring, must be excused from the Agility trial. Any dog which the judge feels is not in control will be excused from the Agility trial.
4. Any owner, handler, or spectator exhibiting poor sportsmanship or abuse towards a dog or person will be required to leave the show site for the duration of the trial, will be reported to ASCA and may be banned from further TNASC events.
5. No leads, collars, food, toys, etc will be allowed on the course.
6. No choke, pinch or prong collars are allowed on the trial grounds
7. All dogs must be on lead or securely crated when not in the ring.
8. The organizing committee of this event reserves the right to refuse any entry based on suitable causes only. Anyone who is not in good standing with TNASC or ASCA will not be allowed entry.
9. Dog sales or puppies under eight weeks are not permitted on the trial grounds

RELEASE

1. Handlers through entry at this event accept full responsibility for themselves, their guests and the actions of their dogs.
2. All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only but may not videotape any portion of this event for commercial or other purposes. All video, broadcast and telecast rights for this event are the exclusive property of ASCA.
3. Portions of this event may be taped for television. Through entry at this event, ALL COMPETITORS AND HANDLERS HEREBY GRANT TO ASCA and its representatives, agents and assigns, all rights and permission to use or appropriate his/her and their dog's name, biography, likeness, photograph, voice, performing persona, or other indicia of identity for broadcast, telecast, cable cast, transmission or distribution in any format or media known. All competitors and handlers hereby release ASCA and its representatives, agents and assigns from any claims or cause of action for invasion of rights of privacy, right of publicity, right of personality, or any similar right.

BEHAVIOR

1. Competitors are responsible for the behavior of their dogs and children. Any competitor whose dogs or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may be asked to leave the show site. No refund will be made.
2. Handlers caught not picking up after their dog may be asked to leave the show site and no refund will be made.

HELPFUL ASCA ENTRY INFORMATION

ENTRY LEVEL

If your dog is completing in an open, advanced, excellent, masters, or elite level in another recognized agility venue, then you may enter the corresponding level at this trial. However, if you are registered with ASCA and want to earn ASCA titles, it is recommended that you begin in the novice level as all points earned will first be applied toward the earning of any titles at the novice and/or open ASCA levels. In the event your dog qualifies at a higher level then it cannot compete at a lower level.

REQUIRED MEASUREMENTS

Dogs entering the standard division jump height classes 20" or less (with height less than or equal to 20"), that do not have permanent ASCA, AKC or NADAC height card must be measured. All dogs that require measuring must present a permanent height card or be measured before the dog's first run of the trial.

If a dog was not measured and competed in a jump height class lower than eligible for any qualifying scores AND PLACEMENTS earned at the incorrect jump height are forfeited. The only exception is a 20+" dog that competed in the 20" jump height class. That dog will be moved immediately to 20+" and all placements earned will be forfeited.

Any dog that measures higher than the entered jump height for that trial has two options:

1. Move dog to the higher jump height
2. Run in the entered jump height, but move to the FEO division (For Exhibition only)

Any dog that cannot be measured for any reason must jump 20+" or move to the FEO division (enter at the desired jump height) for the trial.

Copies of approved height cards may either be mailed with trial entry form or presented at trial check in. Trial secretaries may note a dog's height card as "on file" for future trials hosted by the same affiliate to avoid having to re-verify a dog's height.

The trial judge of record has the right to re-measure a dog believed to be running in the wrong jump height class at any time. In the event of a question concerning a dog's actual height, the exhibitor must re-present the card or the dog to verify the actual height.

Jump Height Exemptions:

The following dogs 'may' jump 4" lower than indicated for their wither height if their breed is listed below: Am. Staffordshire Terrier, Australian Terrier, Basset Hound, Bulldog, Bull Terrier, Cairn Terrier, Cardigan & Pembroke Welsh Corgi, Cavalier King Charles Spaniel, Clumber Spaniel, Dachshund, Dogue de Bordeaux "DDB", French Bulldog, Glen of Imaal Terrier, Miniature Bull Terrier, Petite Basset Griffon Vendeen, Pug, Scottish Terrier, Shar-Pei, Skye Terriers, Staffordshire Bull Terrier, Swedish Vallhund, West Highland White Terrier.

Divisions, Levels, and Classes

The ASCA certification structure is based upon **classes**, divisions and *levels*. The certification **classes** are **Regular Agility, Jumpers and Gamblers** classes. The divisions offered are Standard, Veterans, and Junior Handlers. The three levels offered are *Novice, Open and Elite*.

Divisions:

Standard Division-Entry Requirements

The Standard Division is open to any dog aged 18 months or older. A handler may not enter a dog in more than one division of the same class on any one day of a trial.

Veterans Division-Entry Requirements

The Veterans Division is open to any dog age seven (7) or older, or any handler aged 60 or older, or any handler who has a certificate of disability. The dog's age shall be determined by the dog's actual birthday or the closest date as known. The handler's age shall be determined by a birth certificate or any valid document giving date of birth. Disabled handlers shall present a copy of their disabled parking permit or a letter from their doctor. Dogs entered in the Veterans Division classes will jump 4" lower than their regular jump height. Course times for dogs entered in the Veterans Division of the Regular Agility and Jumpers classes shall be 10% greater than the SCT for the Standard Division. The gamble time in the Veterans Gamblers class shall be two seconds longer than the gamble time for the Standard Division. The maximum course time shall remain the same as the Standard Division.

Junior Handlers Division-Entry Requirements

The Junior Handler Division is open to any dog that is being handled by a junior handler who is 17 years of age or younger. Dogs entered in the Junior Handlers Division classes may chose to jump 4" lower than their regular standard jump height. Standard course times for dogs entered in the Junior Division of the Regular Agility and Jumpers classes shall be 10% greater than the SCT for the Standard Division. The gamble time in the Junior Gamblers class shall be two seconds longer than the gamble time for the Standard Division. The maximum course time shall remain the same as the Standard Division.

Levels:

Novice Level

The Novice level is the first entry level for every class. The Novice level is for any dog which has not yet earned ASCA certification in a particular class. The purpose of dividing any class level into A/B categories is in the fairness of competition. If the dog and handler are just beginning Agility competition, they should compete in the Novice A category. If the dog or handler has previously earned a Regular Agility Standard – Novice (RS-N) certificate, a Gamblers Agility Standard – Novice (GS-N) certificate, or a Jumpers Agility Standard – Novice (JS-N) certificate or any of the equivalents from any international style agility association, then they must enter in the Novice B category for that particular class.

Open Level

The open level is for dogs which have earned a Novice title in that particular class.

Elite Level

The elite level is for dogs which have earned an Open title in that particular class.

Titling Classes:

Regular Agility:

In all divisions, certification in the Regular Agility Classes will require thirty (30) points.

Gamblers Class:

In all divisions, certification in the Gamblers Agility Classes will require twenty (20) points.

Jumpers Class: In all divisions, certification in the Jumpers Agility Classes will require twenty (20) points.

NON-REGULAR CLASSES:

Pre-Novice Classes

Host clubs may offer Pre-Novice classes for dogs over the age of 12 months. Any dog younger than 18 months of age must jump at least 4" lower than their 'standard' jump height. The teeter-totter and weave poles may not be used. Other obstacles may be omitted at the discretion of the host club. Pre-novice courses are not required to be judged by the judge of record and course review is not required.

For Exhibition Only:

Host clubs may accept "For Exhibition Only" (FEO) entries, if they choose. The minimum age for dogs entered "For Exhibition Only" is 15 months of age. Any dog younger than 18 months of age must jump at a lower height than their regular jump height.



ASCA® Service Membership and Tracking Number Application

Beginning 1/1/2003 for non-ASCA® registered dogs – In order to have ASCA® qualifying legs tracked and to receive ASCA® titling certificates, each non-ASCA® registered dog will be required to have an ASCA® Tracking Number. This is a one-time fee of \$10/dog. At the time of applying for the tracking number, the individual owner must also be an ASCA® member (minimum membership type of "Service" is required). ASCA® membership does not need to be maintained in subsequent years. **It will be the responsibility of the owner to identify to ASCA® the show(s) and leg(s) earned when applying for a Tracking Number for those ASCA® qualifying legs earned from 1/1/2003 until submission of application.**

1.1 As used here "ASCA" means the Australian Shepherd Club of America, its affiliate clubs and each of their members, officers, directors, employees, show chairs, show committees and agents.

1.2 Exhibitor/owner, agree to abide by the rules and regulations of ASCA and any other rules and regulations appearing in the premium for this event.

1.3 Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs, or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.

1.4 Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including, but not limited to, the condition of the floors, stairways, halls, lighting, security measures or lack of, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.

1.5 Exhibitor/owner release ASCA (including both club officers, directors, employees, and members), Tennessee ASC (including its officers, directors, and members, and event organizing committee), the East Tenn. Agricultural Exposition Center, (including its owners, agents, and employees) and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor /owner hereby specifically assume sole responsibility for and agree to indemnify and save aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury, or death may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.
