- □ Double Room \$3100.00 semester / \$6200.00 per year
- □ Single Room \$3800.00 semester / \$7600.00 per year

I understand that I must pay my security deposit (\$250.00) with this Housing Contract. It can't be paid with financial aid funds. I plan to pay my housing fees: (Check one)

- □ A. In full for the year. Fee is due July 1<sup>st</sup>. Must be paid out-of-pocket, not with aid/loans.
- □ B. By semester. Fall fee is due July 1<sup>st</sup>. Spring fee is due December 1<sup>st</sup>. Must be paid out-of-pocket, not with aid/loans.
- □ C. Using excess financial aid funds. I understand that if I wish to pay the minimum out-of-pocket of \$250.00, I must have verified sufficient aid, excluding work study to cover the cost of housing fees, tuition, estimated expenses for books, and a cafeteria plan as calculated by College Village.

Payment can be made by check, money order, or credit card (Visa, MasterCard & Discover). Credit card payments must include, type of card, name as it appears on card, account number, expiration date, and 3 digit security code.

# TIPS FOR STUDENT SUCCESS IN RESIDENCY

- ☑ If you have not visited the Campus, make plans to know where you will be living and learning.
- If you are using excess financial aid to pay for housing you will not receive any refund of grants or loans for several weeks and up to 10 or more weeks into the semester. You will need to plan for living expenses during this time.
- Students receiving maximum amounts of aid will need to pay a minimum out-of-pocket of \$250.00, not from financial aid, prior to getting a room assigned. You might need to take out a student loan unless you have additional funds available.

## LICENSE AGREEMENT ACKNOWLEDGEMENT | 2016-2017

1. I understand that the payment of my housing fees at College Village is solely my/our responsibility. I also understand that, if at any time or for any reason I lose any of my scholarships, loans, or financial aid, my guarantor and I are responsible for immediate payment of all outstanding housing fees.

If I (parent borrower) am eligible for a credit balance refund, I wish the proceeds to be released to Genesee Community College Foundation Housing Services, Inc. (College Village).

- 2. I authorize Genesee Community College to release pertinent educational information, including but not limited to financial aid, to College Village.
- 3. I authorize Genesee Community College to direct financial aid checks to cover housing fees: I anticipate one or more financial aid refund checks due to excess federal Title IV financial aid funds. By signing here, I request that Genesee Community College release any excess financial aid refund checks to Genesee Community College Foundation Housing Services, Inc. (College Village) for payment of housing fees. I agree to endorse refund checks to GCCFHS, Inc. immediately upon request. I understand that I may revoke this authorization at any time prior to such release by notifying Genesee Community College Business Office in writing. If I should revoke such authorization, all outstanding balances will be due and payable immediately.
- 4. I understand that:
  - **A.** This license is for one full academic year. I understand that there is no provision for termination of the license. I will be responsible for payment of all financial obligations for the upcoming academic year.
  - **B**. I will take responsibility for my academic success. If I fail to succeed, I understand that I am still responsible for payment of my housing fees.
  - **C.** I will take responsibility for obtaining financial aid and complying with all financial aid requirements. If I fail to maintain my financial aid, I will be responsible for immediate payment of all outstanding financial obligations.
  - D. I will check my Genesee Community College e-mail account on a daily basis for important College Village messages.
  - E. Genesee Community College is a respectful college community. I will be responsible for:
    - My actions.
    - Treating all faculty members, staff members, and fellow students with respect.
    - Complying with the College's Code of Conduct, and all College Village rules and regulations.

If I am dismissed from Genesee Community College and/or College Village for any reason, I will be responsible for payment of all outstanding financial obligations.
