#### **SECTION C-1: SPECIFIC PRE-QUALIFICATION REQUIREMENTS**

- 1. All firms **MUST** provide certified copies of genuine documents (**MANDATORY**) as indicated below:-
  - 1.1 Identity Card(s)/Passport(s).
  - 1.2 Registration Certificate from the National/County treasury as a Micro-enterprise
  - 1.3 PIN/VAT Registration Certificate.
  - 1.4 Tax Compliance Certificate (Newly registered firms must provide proof for exemption on this requirement).
  - 1.5 Partnership Deed for Partnership Business.
- 2. All firms will be required to engage into contract with the University on **CREDIT** terms for at least **30 days**.
- 3. All firms must have not been debarred from engaging into business with a public entity.
- 4. All firms must provide evidence of existing Business Premise (Provide details of physical Address, mobile phone, email address and telephone number).
- 5. All firms must complete the forms attached herein with correct information as required and MUST also be signed and stamped by the authorized officer(s).
- 6. Each Application Form should be used for only one specific category.

#### **SECTION C-2 - INSTRUCTIONS TO CANDIDATES**

#### **C2.1** Scope of Tender

- 2.1.1 Maseno University herein after referred to as the procuring entity intends to prequalify enterprises owned by youth, women and persons with disabilities for the supply of goods and services. It is expected that pre-qualification applications submitted to be received by the Procuring entity not later than 14<sup>th</sup> February 2014 at 10.00 a.m.
- **2.1.2** Prequalification is open to eligible firms and voluntarily formed joint ventures as described in the Tender Advert.

#### **C2.2 Submission of Application**

2.2.1 Applications for pre-qualification shall be submitted in sealed envelopes marked with the tender name and reference code and deposited in the tender box at Maseno University or be addressed to:

The Vice Chancellor, Maseno University, P.O Box Private Bag Maseno

so as to be received on or before **14<sup>th</sup> February 2014 at 10.00 a.m.** The procuring entity reserves the right to accept or reject applications.

- 2.2.2 The name and mailing address of the applicant **SHOULD NOT** be marked on the outer envelope containing the application.
- 2.2.3 All the information requested for pre qualification shall be provided in the English language. Where information is provided in any other language, it shall be accompanied by a translation of its pertinent parts into English language. The translation will govern and will be used for interpreting the information.
- 2.2.4 Failure to provide information that is essential for effective evaluation of the applicant's qualifications or to provide timely clarification or substantiation of the information supplied may result in the applicant's disqualification.

#### **C2.3 Eligible Candidates**

- 2.3.1 This invitation for pre-qualification is open to all candidates who are eligible as defined in the tender advert and as indicated in the instructions to candidates.
- 2.3.2 The procuring entity's employees, committee members, board members and their relative (spouse and children) are not eligible to participate in the tender unless where specially allowed under the Procurement Act.
- 2.3.3 All terms found capable of performing the contract satisfactorily in accordance to the set prequalification criteria shall be prequalified.

#### **C2.4 Qualification Criteria**

2.4.1 Pre-qualification will be based on meeting the minimum requirements to pass in the criteria set as shown in this document. The declaration will be either pass or fail regarding the applicant's response to pre-qualification requirements. The procuring entity reserves the right to waive minor deviations if they do not materially affect the capability of an applicant to perform the contract.

### 2.4.2 **General Experience**

The applicant shall meet the minimum criteria set out in this document.

## 2.4.3 **Litigation**

History the applicant should provide accurate information on any litigation or arbitration resulting from contracts completed or under its execution over the last five years. A consistent history of awards against the applicant or any partner of a joint venture may result in failure of the application.

### **C2.5** Public Sector Companies

2.5.1 Any public owned enterprise SHALL NOT be eligible to qualify.

#### **C2.6.** Conflict of Interest

2.6.1 The applicant (including all members of a joint venture) shall neither be associated, nor have been associated in the past, with the consultant or any other entity that has prepared the design, specifications, and other prequalification and bidding documents for the project, or with an entity that was

proposed as engineer for the contract. Any such association must be disclosed and may result in the disqualification of the applicant.

## **C2.7. Updating Pre-qualification Information**

2.7.1 Pre qualified candidates shall be required to update the financial information used for pre qualification at the time of submitting their bids and to confirm their continued compliance with the qualification criteria. A bid shall be rejected if the applicant's qualification thresholds are no longer met at the time of bidding.

Maseno University Evaluation Committee shall evaluate the tenders on the basis of their responsiveness to the pre-qualification requirements as specified in this document.
