Request to CASA to record a Certified Designee Confirmation Letter (CDCL)

International Interests in Mobile Equipment Rules 2014 (Rules)

IMPORTANT INFORMATION FOR APPLICANTS

1: Comprehensive information about completing this form can be found on CASA's website www.casa.gov.au/idera.

2: This form must be completed and signed by the current authorised party.

3: All blank spaces must be completed and, where applicable, the details must be as recorded on the aircraft's certificate of registration.

4: The beneficiary of a Certified Designee Confirmation Letter (CDCL) (the certified designee) must have an Aviation Reference Number (ARN) in order for the CDCL to meet CASA's requirements and be recorded on the Australian Civil Aircraft Register.

5: This form must be signed and submitted in **original hard copy** to the Civil Aircraft Register, Civil Aviation Safety Authority, Australia by mail or courier. The application **cannot be accepted via email or fax** as per the legislative requirements.

6: CASA does not accept electronic signatures.

7: This form has specific power of attorney requirements in relation to signatures - see the guidance material

8: By lodging this request the authorised party accepts that, provided the CDCL meets all requirements and no other certified designee is recorded, CASA will record the CDCL on the Australian Civil Aircraft Register.

9: Payment for this application can be made online. Go to the CASA webpage and click the Payment button. You must attach a copy of the receipt with this application.
