Freedom of Information Request Procedures

Procedures:

The Freedom of Information Act, 5 ILCS 140/3 et seq., is the principal Illinois Statute governing the inspection of public records. The Act requires that public bodies make available for inspection or copying all public records to any person. Exceptions are provided to insure the confidentiality of certain types of sensitive public records.

Persons desiring to inspect or receive copies of City records must submit a request in writing or may complete a FOIA REQUEST FORM.

All requests for records must be received during normal business hours of the general administrative offices of the City (Monday through Friday between the hours of 8:00 am and 5:00 pm excluding holidays). Requests submitted electronically after normal business hours will be considered by the City on the next business day.

Upon receipt of a general request, the City will respond within five working days of the date of the request.

Fees:

- Standard black & white copies of records 1st 50 pages free. Remaining copies are .15 per page.
- Color copies of records of copies in a size other than letter or legal .15 per page
- Maps, photographs, CD's, DVDs, etc: Actual cost of reproduction
