How Evictions Work: Rules for Landlords and Property Managers Landlords may usually use a 30-Day or 60-Day Notice to Vacate to end a month-to-month tenancy when the tenant has not done anything wrong. Many rent control cities, however, do not allow this; they require the landlord to prove a legally recognized reason for eviction (just cause) of tenants. EVICTION NOTICE
