**OSHA's construction regulation on cranes mandates that anyone signaling a crane MUST be qualified as a signal person. This qualification requires both practical and written testing of specific aspects to demonstrate qualification.**

**This program is intended to meet the training requirements for Maryland Level I Rigger and OSHA's Crane Signal Person qualification. A wallet card is given upon successful completion of written and practical testing. Note: Maryland also requires riggers and signal persons to be enrolled in a DOT-compliant drug testing program to be considered qualified.**
