



## Sample Professional Resumes

Attached are two sample resumes (of "real" people), edited to hide their identity. Good cover letters are more difficult to pinpoint, because they are all so different. Some basic requirements for a cover letter should contain:

1. A *brief* cover letter (email)

2. that tells me which position they are interested in,

3. *what relevant experience* they have (i.e., why they believe they are qualified),

4. *why they are interested* (e.g., relocation for family reasons, RIF, new challenge, etc.), and

5. whether there is anything on their resume they need to explain.

What should be avoided are typos, misspellings, or a letter addressed to the wrong person (from a prior letter that was not changed). And again, the shorter the better; if it's too long (more than 2 paragraphs) it may not be read fully.

#### SIGNIFICANT LITIGATION EXPERIENCE

- Jacob Marsh et. al. v. Global Products (Federal court Missoula, MT 2003) Over 300 plaintiffs claimed personal injury from exposure to PCB's and dioxins from predecessors' site operations. Obtained dispositive ruling on causation/expert grounds just before trial.
- <u>Orange County Office Building Fire Litigation</u> (State court Los Angeles, CA 2003) 22 suits by families of six deceased and numerous injured plaintiffs arising out of tragic building fire in which Global Clothing product was only alleged cause of fire. Obtained unprecedented summary judgment.
- <u>Used Battery Class Action Litigation (State and federal courts VA, NC, NY, OH 2003)</u> Multiple class action suits alleging billions of used batteries were defective and presented risk of fire. Aggressive defense of merits and class certification positioned cases for extremely favorable resolution.
- <u>Donaldson v. Dukes</u> (State court Sunnydale, CA 2002) Multi-party environmental contamination suit allegedly resulting from defective convertible parts. After three-month trial of bellwether sites, Global obtained directed verdict.
- Jack Tolbert *et. al.* v. Global Products (State court Evergreen, AL 1996) \$1 million+ property loss arising from fire allegedly due to a defective circuit in a toy. Defense verdict after 3-day trial.
- <u>David Stewart v. Global Products</u> (Federal court Miami, FL 1996) Wrongful death of 29 year- old factory worker involving tool that was allegedly improperly guarded. After 6-day trial, jury found decedent was 75% at fault and awarded widow and family \$125,000.
- <u>Bobby Thorne v. Global Products</u> (State court Kansas City, KS 1995) Personal injury suit claiming defective design of fluorescent toy part. Defense verdict.
- <u>Patricia Wells v. Global Products</u> (State court Ithica, NY 1995) Wrongful death case alleging decedent's asphyxiation was due to defective design of a Global product used in manufacturing plant. Plaintiffs accepted \$300,000 settlement after 5-week bench trial.
- <u>Global Products v. Auto Garages</u> (Federal court Hattiesburg, MS 1995) Breach of contract, warranty and product liability suit as a result of a defective garage door on a Global Clothing manufacturing facility. After a 6-day trial, the jury awarded Global \$1.64 million the entire amount sought by Global.
- <u>Ronald Isley v. Global Products</u> (State court Princeton, NJ 1995) Wrongful death of assembly worker due to allegedly defective product. Defense verdict after 3-week trial.
- <u>Edgar Jimenez v. Global Products</u> (State court San Diego, CA 1993) Plaintiff suffered burn injuries to hand and arm due to allegedly defective ironer. Verdict for Global after 3-week trial.
- <u>Dina White v. Global Products</u> (State court Loughfton, KY 1993) Wrongful death product liability case alleging failure to have backup alarm and other defects in a factory. Defense verdict after 3-day trial.
