From Your Administrator...

If I was the Governor of MN...I would give all of my employees raises!!! It is interesting that in mid-February, Governor Dayton drafted his state budget and did not include any additional funding for nursing homes because "They received 5% last year!", and yet he gave his commissioners substantial raises because "it is the right thing to do if you want the best". We believe in having the best staff to care for our residents and patients. However, because our payments are fixed by the State of Minnesota, we lose great staff to other jobs because of pay.

I testified last month at the newly formed Committee on Aging along with other healthcare professionals. I stated that in 2014, we lost 20 nursing assistants and 6 Registered Nurses because they said they had another job that paid more. In a hospital setting, a nursing assistant can make \$8,000 more while a Registered Nurse can make \$35,000 more per year. We even lose staff to non-healthcare jobs.

I also attended a town hall meeting in Maple Grove where Representative Joyce Peppin, Representative Dennis Smith and Senator Warren Limmer presided at. When nursing home funding was brought up, Rep. Peppin stated that her mom was in a nursing home. When she would visit her, she would wonder if there would be different staff taking care of her because of the turnover. One person in the audience asked "Why don't they pay them more?" Rep. Peppin asked me to comment on that which I was more than happy to do. I stated that the state of MN has fixed payments to nursing homes regardless of what the cost is. I went on to say that if we gave increases, we could not pass any of the additional cost on. Another person at the meeting stated "That doesn't make sense!" I simply agreed with him. In his budget, Governor Dayton also stated how important it is to improve the transportation system in Minnesota. He stated that "We can't simply keep kicking it down the road or putting it off. If we do, it will cost us too much in the end." Instead of the word "transportation" he could use "senior care". Please contact Governor Dayton and tell him how important it is to have experienced and quality staff caring for you or your loved one. Remind him that 60,000 people per year are turning 65, and that trend will continue for the next 15 years. It will take all of us – seniors, families, caregivers, government and communities – working together to serve the needs of Minnesota's growing senior population. Supporting long term care in the supplemental budget to create a continuum of senior care that lets aging Minnesotans preserve their quality of life for as long as possible, in their communities and near their families.

Longing for the Light

Today, while writing this article, the sun shines brightly on a snow-covered lawn. It sparks my mood and my productivity to think we are emerging from the winter of so many cloudy, dreary days.

Did you know here in Minnesota we are gaining approximately 3 minutes of sunlight each day during the month of March? (We begin March with 11 hours, 8 minutes of sunlight and end the month with 12 hours, 43 minutes of sunlight.)
